At Councilmember Kreitler's inquiry, staff reported there is \$150,000 budgeted for these bid items. Staff screens the rates in the regionally competitive market. Internal costs of operation are hard to recover.

Deputy Mayor Pro-tem Savage and Citizen Swart pulled the item.

At Citizen Swart inquiry, staff reported the project would not be funded out of the 1¢ maintenance funds adopted as part of the 2018 budget and that other funds had previously been set aside for the project.

Wayne Lisenbee, Director of Facilities & Capital Improvements, presented the item. The bidding came in under budget. The life cycle of the existing system has been 22 years with the new system's expected to be 10-15 years. The art audio can be programmed and customized per event. The warranty is 1-year parts/labor.

Wayne Lisenbee, Director of Facilities & Capital Improvements, presented the item. The project calls for an effective combination of a stationary curtain system and a digital audio projection system.

Citizen Swart stated his questions had been answered during the conversation. Mayor Pro-tem Savage opined the item should be held until after the funds approved for the other items were expended and projects finalized.

Robert Hanna, City Manager, presented the item. City Manager Hanna appointed Cande Flores as Fire Chief of the Abilene Fire Department. Under Chapter 143 of the State Civil Service Statute, the Chief Executive Officer appoints the Fire Chief and the City Council affirms.

Deputy Mayor Pro-tem Savage moved to approve the item as presented. Councilmember Kreitler seconded the motion; motion carried.

Ordinance & Public Hearing: (Final Reading) TC-2018-04 A request from Hardin Simmons University, agent Enprotec/Hibbs & Todd, to abandon all that portion of right-of-way for Cypress Street, being on the south line of right-of-way for Lowden Street and heading 468 feet toward Vogel Avenue (ASSIGNED ORDINANCE NO. 29-2018)

Ken Flynn, Interim Director of Planning and Development Services, presented the item. Adoption of the item would abandon all that portion of right-of-way for Cypress Street, being on the south line of right-ofway for Lowden Street and heading approximately 468 feet toward Vogel Avenue. Staff clarified that if the two owners who agreed to the abandonment change their minds after Council approval, the property would remain paved and the abandonment would occur south of the property. The abandonment would occur at time of replat with the owners signing off on that.

Mayor Williams opened the public hearing. The following addressed the city council:

Bi Prichard – inquired as to what would happen if the homeowners no longer supported the change; confirmed there is at least one more proposed development in the area.

Ordinance & Public Hearing: (Final Reading) Z-2018-11 A request from Hardin Simmons University, agent Enprotec/Hibbs & Todd, to rezone property from HC/COR (Heavy Commercial/COR Overlay), HC (Heavy Commercial), and RS-6 (Residential Single-Family) to CU/COR (College University/Corridor Overlay) and CU (College University) to allow for university and related uses on property located just north of Hardin Simmons University. Location being 10 parcels located north of Vogel Avenue and south of Lowden Street, between Cedar Street and Pine Street

(ASSIGNED ORDINANCE NO. 30-2018)

Ken Flynn, Interim Director of Planning and Development Services, presented the item. Adoption of the item would rezone 10 parcels of land at locations within the area noted on the agenda caption.

Mayor Williams opened the public hearing. The following addressed the city council.

Bj Prichard – confirmed someone else had owned the vacant gas station.

With no other speakers coming forward, Mayor Williams closed the public hearing.

Mike Rains, Director of Finance, presented the item. Adoption of the item would authorize the sale of certificates of obligation for the new Law Enforcement Center, Municipal Court, Marshal and Water Utilities offices and Records Storage building in the former Kmart building. In addition, the bonds would include funds for Griffith Road street improvements. Mr. George Williford with Hilltop Securities detailed the report distributed to the City Council, encompassing information applicable to Agenda Items 16-18. The Preliminary Financial Statement outlined in the handout were the same as included in the presentation but would later be updated once all is final.

Deputy Mayor Pro-tem Savage moved to approve the item as presented. Councilmember Kreitler seconded the motion; motion carried.

(ASSIGNED ORDINANCE NO. 32-2018)

Mike Rains, Director of Finance, presented the item. Adoption of the item would approve the issuance and sale of the 2018 General Obligation bond issuance. The bonds are part of the 2015 voter approved bond referendum and would include funds for street improvements and airport matching funds for Federal Aviation Administration grants. Staff to provide the total savings cost from street improvement projects approved by City Council that have been come in under budget.

Deputy Mayor Pro-tem Savage moved to approve the item as presented. Councilmember Albus seconded the motion; motion carried.

Mike Rains, Director of Finance, presented the item. Adoption of the item would approve the issuance and sale of 2018B certificates of obligation for the City's portion of improvements for the Abilene Youth Sports Authority's planned Sports Complex at Nelson Park.

Councilmember Price moved to approve the item as presented. Deputy Mayor Pro-tem Savage seconded the motion; motion carried.

19. Resolution: Creating Trip Factor Indexes for use in calculating individual Street Maintenance Fees as established by the Street Maintenance Fee Ordinance (ASSIGNED RESOLUTION NO. 97-2018)

Andy Anderson, Interim Director of Public Works, presented the item. Adoption of the item would approve the Trip Factor Indexes, which were based on the Institute of Transportation Engineers Trip Generation Manual, 9th Edition with modifications made by the City and including only those categories staff felt applied. Approval allows citizens an advance view of how the charges will work/apply to them. As the implementation process is underway, staff agrees changes will be needed; such changes can be made through an amendment to this resolution.

Mayor Williams opened a public hearing. The following addressed the city council:

- Bob Thomas agrees with the trip factor but opined the Street Maintenance Advisory & Appeals Board should be given something that does not have to be reconfigured
- David Swart need to address unique businesses rather than placing them with the big guys

With no other speakers coming forward, Mayor Williams closed the public hearing.

Mayor Pro-tem McAlister moved to approve the item as presented. Councilmember Kreitler seconded the motion; motion carried.

20. Ordinance & Public Hearing: (Final Reading) Amending Chapter 18, "Motor Vehicles and Traffic," Article XIII, "Schedules," Sec. 18-293. "Parking Prohibited-At All Times," by amending certain sections; providing a severability clauses; and declaring a penalty (ASSIGNED ORDINANCE NO. 34-2018)

Andy Anderson, Interim Director of Public Works, presented the item. Adoption of the item would officiate staff's traffic engineering action (recently implemented for safety purposes) to move "NO Parking" signage south of Potomac Avenue. Up to this point, the signage has served as an educational effort with no fines issued; adoption would make the "No Parking" enforceable.

Mayor Williams opened the public hearing. With no speakers coming forward, Mayor Williams closed the public hearing.

Deputy Mayor Pro-tem Savage moved to approve the item as presented. Councilmember Hurt seconded the motion; motion carried.

21. Ordinance & Public Hearing: (Final Reading) Adopting the Street Maintenance Fee ordinance (ASSIGNED ORDINANCE NO. 35-2018)

Andy Anderson, Interim Director of Public Works, presented the item. Adoption of the item would institute a Street maintenance Fee. The results of the May 5, 2018 Special Election were that a majority of the voters voted in favor of the City establishing such a fee. The equity of setting such a fee was discussed in the areas of senior citizens, disabled, renters, and property/apartment owners. Removing all fee structures or having every one pay the same fee were noted as options. Staff reported the ordinance established a method of appeal and review by the Street Maintenance Advisory and Appeals Board.

Councilmember Price proposed an amendment to provide that the Street Maintenance Advisory and Appeals Board evaluate the fees every spring rather than every four (4) years as currently stated in the ordinance.

Having spoken to the senior citizen community, Councilmember Albus recommended proposed exemptions be removed except for income-based exemptions.

Mayor Williams opened the public hearing. The following addressed the city council.

- David Swart reported email was sent to the City Council, with some of his questions being answered; consider the over 65, disabled and lower income be accepted exemptions
- Herman Barren tunnel vision in setting up the fees; should consider fee payment based on vehicles versus households as a lot of homes have many cars
- Tammy Kister representing Big Country Apartment Association; unfair to properties having low occupancy rate by making them pay the fee for all apartment units; feels fee is not equitable
- Jud Beall provided examples of possible exemptions and requiring documentation to qualify; in support of the fee
- Ron Kinder what everybody voted to do is already being changed
- Johnnie Fluke the community voted and things are now being changed; consider doing incomebased with documentation; if keeping at 65+ and disabled need to consider those that rent

- Bob Thomas agrees with the board reviewing annually; future councils will be voting on these fees; need to move upward on the issue
- Oscar Aguilar need to move forward on this; don't depend on citizens; citizens depend on city council
- Jay Riley citizens approved; do what the public said to do; exemptions need to require documentation

With no other speakers coming forward, Mayor Williams closed the public hearing

Brief commentary by the City Council on its accountability to the citizens.

Mayor Williams moved to approve the item with the following changes:

- The Street Maintenance Advisory and Appeals Board evaluate the fees every spring rather than every four (4) years as currently stated in the ordinance (as proposed by Councilmember Price); and
- Remove the reduced rate option for "Over 65 and Disabled" (as recommended by Councilmember Albus).

Councilmember Albus seconded the motion; motion carried.
