## CITY COUNCIL MEETING April 9, 2020 at 8:30 a.m.

# CITY COUNCIL OF THE CITY OF ABILENE, TEXAS COUNCIL CHAMBERS, CITY HALL

The City Council of the City of Abilene, Texas met in Regular Session on the April 9, 2020, at 8:30 a.m. in the Council Chambers, 555 Walnut St. Mayor Anthony Williams was present and presiding with Mayor Pro-tem Weldon Hurt, Deputy Mayor Pro-tem Donna Albus and Councilmembers Shane Price, Jack Rentz, Kyle McAlister and Travis Craver. Also present were City Manager Robert Hanna, City Attorney Stanley Smith, City Secretary Shawna Atkinson, and various members of the City staff.

Councilmember Jack Rentz delivered the invocation and led the Pledge of Allegiance to the Flag of the United States of America and State of Texas Flag.

This meeting was broadcast over a teleconference to allow the public to call in via telephone, since the meeting and City Hall were closed to the public during the current disaster situation.

City Manager Robert Hanna clarified that we have not touched the Street Maintenance funds yet because they restricted funds. The Development Corporation of Abilene funds haven't been decreased either. Future projects may be effected, but not this one.

Having pulled the item, David Swart questioned why the City is replacing a roof on a National Guard building. and asked if this building was leased by the city. He also questioned if the funding for the project is coming from the lawsuit from the 2014 hailstorm.

City Manager Robert Hanna clarified that the building was given to the City by the National Guard and houses many City departments. He also stated he insurance proceeds from the 2014 hailstorm are going to fund this project.

Ordinance (Final Reading): Receive a Report, Hold a Discussion and Public Hearing, and Take Action on a request from the City of Abilene to abandon public right-of way within an 80' wide segment of Cedar Street extending 300' between the north line of right-of-way for North 5th Street and the south line of right-of-way for North 6th Street; and a request to abandon public right-of-way within a 20' wide alley extending 300' between the north line of right-of-way for North 5th Street and the south line of right-ofway for North 6th Street, midway and parallel between Cypress and Cedar Streets [ASSIGNED ORDINANCE NO. 14-2020]

Mike Warrix, Director of Planning and Development Services, presented the item. Adoption of the item would abandon the above referenced public right-of-ways associated with the downtown hotel project.

Mayor Williams opened the public hearing. With no speakers coming forward, the public hearing was closed.

Councilmember McAlister moved to approve the item as presented. Councilmember Price seconded the motion; motion carried.

Mike Warrix, Director of Planning and Development Services, presented the item. Adoption of the item would abandon the above referenced right-of-ways. He also clarified that there are no utilities present.

Mayor Williams opened the public hearing. The following addressed the Council:

Jeff Prince, applicant - stated he wanted to be present to state his case. Also stated that there was a problem on the plats and he had to spend money on correcting, that this will clean things up in the area and will not negatively affect the neighbors.

With no other speakers coming forward, the public hearing was closed.

Councilmember Price moved to approve the item as presented. Mayor Pro-tem Hurt seconded the motion; motion carried.

#### PUBLIC COMMENTS

Mayor Williams opened the public comment period. The following addressed the city council:

David Swart - spoke about the health crisis we are in and stated that a while ago the city had furlough days and questioned if it might happen again. Mr. Swart stated Good Friday is tomorrow and encourages everyone to stay positive.

Robert Hanna, City Manager addressed Mr. Swart's concerns about furloughs. He stated that he does not anticipate furloughing employees, but that non-essential employees have already been sent home. These employees are using leave balances and administrative leave to continue to receive pay.

Michelle Taylor - wanted clarification on why private doctors are refusing to test patients. She stated she had a fever and a cough and they would not test her for COVID-19. Ms. Taylor also stated her husband works at a car lot where they cannot practice social distancing well, and asked when we will go into a full shelter in place.

Mayor Williams gave Ms. Taylor the phone number for Hendrick Health Screenings and stated he could not speak on behalf of private doctors.

Robert Hanna, City Manager stated that Abilene is doing a good job of flattening the curve and the current order seems to be working at this time. He encouraged Ms. Taylor to go to the Governor of Texas's website to get information on the list of essential businesses.

With no other speakers coming forward, the public comment period was closed.

Earlier in the meeting, under Section 551.071 (Consultation with Attorney) of the Open Meetings Act, the item was discussed during the Executive Session, which started at 9:09 a.m. and ended at 10:50 a.m. No votes or actions were taken at that time.

Robert Hanna, City Manager, presented the item. Adoption of the item would postpone the May 2, 2020, General Election until November 3, 2020, or an earlier date, if possible.

Council questioned if a date earlier than November is possible. City Attorney Stanley Smith clarified that November is the only option at this time, but it is possible to appeal to a District Court Judge in conjunction with other agencies in the area, and ask to be able to move it to a different date. It was proposed that July 14th, would be the best date to ask for, as the Governor of Texas has already moved the Primary Runoff Election to that date, so there wouldn't be an additional burden. Council is in agreement on this and asked City Attorney Smith to start that process.

Mayor Williams opened the public hearing. The following addressed Council:

David Swart- stated that the City has done good research with the Secretary of State on this. Also stated that the July date would be a better alternative, but we don't know how much longer this pandemic will last.

With no other speakers the public hearing was closed.

Mayor Pro-tem Hurt moved to approve the item as presented. Councilmember Price seconded the motion; motion carried.
