CITY COUNCIL MEETING April 23, 2020 at 4:30 p.m.

CITY COUNCIL OF THE CITY OF ABILENE, TEXAS VIRTUAL MEETING

The City Council of the City of Abilene, Texas met in Regular Session on April 23, 2020, at 4:30 p.m. virtually, via Zoom meeting. Mayor Anthony Williams was present and presiding with Mayor Pro-tem Weldon Hurt, Deputy Mayor Pro-tem Donna Albus and Councilmembers Shane Price, Jack Rentz, Kyle McAlister and Travis Craver. Also present were City Manager Robert Hanna, City Attorney Stanley Smith, and City Secretary Shawna Atkinson.

This meeting was broadcast over a teleconference to allow the public to call in via telephone, since the meeting and City Hall were closed to the public during the current disaster situation.

EXECUTIVE SESSION

Mayor Williams recessed into Executive Session at 4:30 p.m. pursuant to the following of the Open Meetings Act, with the following issues discussed during this session, as listed on the agenda and authorized by the noted Texas Government Code Section:

Councilmember Travis Craver delivered the invocation, and led the Pledge of Allegiance to the Flag of the United States of America and State of Texas Flag.

4. Resolution: Receive a Report, Hold a Discussion and Public Hearing, and Take Action to Approve the Purchase of Four Police Packaged Motorcycles from Kent's Harley-Davidson through CB-2042 [ASSIGNED RESOLUTION NO. 80-2020]

The item was pulled by Councilmember McAlister.

Having pulled the item, Councilmember McAlister questioned if any other bids were received and if we were only looking at Harley Davidsons.

Police Chief, Stan Standridge addressed Councilmember McAlister's concern and stated that Kent's Harley Davidson was the sole bidder. We have an in-house trainer that is certified on Harley Davidsons, so if we went with another type of motorcycle, we would have to have them re-certified and it would end up being costprohibitive.

Mayor Williams opened the public hearing. With no speakers coming forward, the public hearing was closed.

Councilmember Price moved to approve the item as presented. Councilmember Rentz seconded the motion; motion carried.

Resolution: Receive a Report, Hold a Discussion and Public Hearing, and Take Action to Approve Operating Cost Relief for American Airlines, Avis/Budget, Hertz and Enterprise-Rent-A-Car [ASSIGNED RESOLUTION NO. 82-2020]

Don Green, Director of Transportation, presented the item. Adoption of the item would approve operating cost relief in the form of deferred payments, for American Airlines, Avis/Budget, Hertz and Enterprise-Rent-A-Car. This will make temporary changes to the rents and charges the Airport imposes through the lease and operating agreements, in light of the current Covid-19 health crisis.

Mayor Williams opened the public hearing. With no other speakers coming forward, the public hearing was closed.

Councilmember Craver moved to approve the item as presented. Councilmember Price seconded the motion; motion carried.

Robert Hanna, City Manager, presented the item. Adoption of the item would award the bid to Dowtech Specialty Contractors for the Northeast WTP Filter No. 5 Replacement.

Mayor Williams opened the public hearing. With no other speakers coming forward, the public hearing was closed.

Councilmember McAlister moved to approve the item as presented. Councilmember Rentz seconded the motion: motion carried.

Resolution: Receive a Report, Hold a Discussion and Public Hearing, and Take Action on Temporarily Suspending the Street Maintenance Fee and Shrinking Tier Levels for Residential Water Customers [ASSIGNED RESOLUTION NO. 84-2020]

Robert Hanna, City Manager, presented the item. Adoption of the item would temporarily suspend the Street Maintenance Fee and shrink the tier levels for residential water customers. Mr. Hanna recommended to Council to suspend the Street Maintenance Fee for two months, with the option to reconsider once that time period is up, and to make no changes to water rates.

Mayor Williams opened the public hearing. The following addressed the council:

- Mariann Ermis would like to see the Street Maintenance Fee suspended for 90 days.
- David Swart stated that since there is a decrease in sales revenue, this would be a good idea. He thinks we should decrease the base water rates down \$5 and suspend the Street Maintenance Fee for 90 days.
- Christina Williams stated she was in favor of the item.
- Charles Byrn questioned on how would we reinstate the Fees, if we were to suspend them. He thinks it would be hard to impose them again and the City would have to be careful on how they do it. Also questioned how we would recover from the shortage of funds.
- Luis Ortiz asked for clarification as to what the suspense means, and if he would not have to pay during this time period.
- Ron Kinder stated that there is no revenue coming in with no schools and residents staying inside. Mr. Kinder stated some families will go over the water usage since they are staying home, putting residents in the next higher tier if this is approved.

Mayor Pro-tem Hurt moved to approve suspending the Street Maintenance Fee for two months. Councilmember Price seconded the motion; motion carried.
