CITY COUNCIL MEETING July 23, 2020 at 4:30 p.m.

CITY COUNCIL OF THE CITY OF ABILENE, TEXAS COUNCIL CHAMBERS, CITY HALL

The City Council of the City of Abilene, Texas met in Regular Session on July 23, 2020, at 4:30 p.m. in the Council Chambers, 555 Walnut St. Mayor Anthony Williams was present and presiding with Mayor Pro-tem Weldon Hurt, Deputy Mayor Pro-tem Donna Albus and Councilmembers Shane Price, Jack Rentz, Kyle McAlister and Travis Craver. Also present were City Manager Robert Hanna, City Attorney Stanley Smith, City Secretary Shawna Atkinson, and various members of the City staff.

EXECUTIVE SESSION

Michael Rice, Assistant City Manager, presented the item. Adoption of the item would approve an extended term street use license with TTY Holdings, LLC, to use a portion of City right-of-way in front of the building addressed as 630 N 5th Street. The applicant will construct and maintain a permanent loading platform and an ADA service ramp.

Mayor Williams opened the public hearing. The following addressed the Council:

• Tim Yandell – spoke on behalf of TTY Holdings. Stated their appreciation of Mr. Rice and all of the staff's help during this process.

Michael Rice, Assistant City Manager, presented the item. This presentation was the final recommendations of the Mayor's Downtown Task Force, Downtown On-Street Parking Plan. The Task Force held a town hall meeting to get input from the community on functional on-street parking downtown, as well as increase the number of spaces. Mr. Rice presented the Task Force's proposals. Mr. Rice also introduced Yvonne Batts, Chair of the Mayor's Downtown Task Force, who stated the board's excitement for this project.

Mayor Williams opened the public hearing. The following addressed the Council:

• David Swart – stated that this is a good idea, but would still like the City to consider something along the lines of a paid parking structure, that would go to free after the structure is paid off. He also questioned if there will be additional money needed to change the streets from two-way to one-way, and vice versa.. Mr. Swart also stated his disapproval of parallel parking as he feels it's a danger with oncoming traffic and possibly losing a door.

With no other speakers coming forward, the public hearing was closed.

After discussion, it was the consensus of Council to leave Pine Street at four lanes, but otherwise go with the Task Force's recommendations, and for Staff to begin preparation to bring this item to Council for an official vote.

This item was for presentation only. No votes or action were taken at this time.

- Cynthia Alvidrez- suggested staff look at the DSHS website and the format they use, as it is more user friendly. She would like to see a seven day average of positivity rate included, as that is what the Governor will use to determine if there needs to be another shutdown.
- David Swart- stated that there is a lot of discussion about the misreporting. He stated that the numbers reported are confusing, and gave an example of the trinity tests from 75 years ago, and how double checking numbers can save lives.

PUBLIC COMMENTS

Mayor Williams opened the public comment period. The following addressed the city council:

- David Swart spoke about adding the Juneteenth holiday for City employees and asked if this would be optional for a city employee to take. Mr. Swart also spoke about his water bill and that he had zero usage but was still billed for water. He stated that there is no explanation on his bill and that they need to be specific on charges.
- Elda Salinas stated to due to COVID everyone has experienced cut backs. She contacted the Taylor County Appraisal District to request a decrease in her property taxes, and they denied her request. She stated that they suggested she contact the City to request a decrease in the tax rate.
- Mary Ross from Workforce Solutions of West Central Texas. Ms. Ross thanked everyone for success at the Convention Center in helping citizens looking for jobs. The City allowed them to have it at the Convention Center and AISD loaned them Chromebooks, and they helped over 100 citizens get jobs. They also had a second event, a virtual job fair, that was a success as well, and thanked the community for their generous support.
- Cynthia Alvidrez stated that she came to the meeting to speak on the Budget Workshop items. Ms. Alvidrez stated that our appraisals have gone up and have increased revenues. She stated people are struggling and we should consider lowering to the 2017 tax rate. This will allow us to keep our budget and not burden citizens. Ms. Alvidrez also stated that she is requesting \$700,000 of the MIP funds available to be used towards upgrades at Arthur Sears Park and went over the various items she is asking for.

Mayor Williams addressed Ms. Alvidrez's comments and let her know the Budget Workshop was held on Tuesday, July 21, 2020, and was concluded that same day. The items on today's agenda were only if they did not get done before then, and he would not be opening the items back up for discussion.

With no other speakers coming forward, the public comment period was closed.
