CITY COUNCIL MEETING December 17, 2020 at 4:30 p.m.

CITY COUNCIL OF THE CITY OF ABILENE, TEXAS COUNCIL CHAMBERS, CITY HALL

The City Council of the City of Abilene, Texas met in Regular Session on November 19, 2020, at 4:30 p.m. in the Council Chambers, 555 Walnut St. Mayor Anthony Williams was present and presiding with Mayor Pro-tem Shane Price, Deputy Mayor Pro-tem Jack Rentz and Councilmembers Donna Albus, Weldon Hurt, Kyle McAlister and Travis Craver. Also present were City Manager Robert Hanna, City Attorney Stanley Smith, City Secretary Shawna Atkinson, and various members of the City staff.

EXECUTIVE SESSION

Mayor Williams recessed into Executive Session at 4:30 p.m. pursuant to the following of the Open Meetings Act, with the following issues discussed during this session, as listed on the agenda and authorized by the noted Texas Government Code Section:

Having pulled the item, David Swart stated that he understands that we have to keep approving this in order to receive funds, and hopes we will know in January if this will continue or not. Mr. Swart gave some statistics on COVID-19 numbers and thinks that small business are being targeted in these shut downs. He thinks this is unfair.

With no other speakers coming forward, the public comment period was closed.

Councilmember Hurt expressed his opinions and concerns in regards to this item, stating that every business is essential.

Robert Hanna, City Manager, presented the item. Adoption of the item would modify and extend the Declaration of Local Disaster issued on October 22, 2020.

Robert Hanna, City Manager, presented the item. Adoption of the item would approve budget cuts and revenue enhancements for Fiscal Year 2021. Mr. Hanna gave the reasoning behind these needed cuts and went over the programs he recommends cutting, and the revenue enhancements he recommends putting in place.

Council discussed the various options on the table at length and gave their opinions on them.

Mayor Williams opened the public hearing. The following addressed the Council:

- David Swart spoke about the senior meal program and questioned the sales tax deficit and if that will affect the money going to the DCOA from sales tax.
- Jenny Goode spoke about 2-1-1 and how Betty Hardwick is interested in taking on Adaptive Rec.
- Sue Davidson spoke in favor of keeping the Adaptive Rec program.
- Leah Beltran spoke in favor of the Adaptive Rec program and having Disabilities in Action help with it.
- JoAnn Fluke spoke in favor of keeping the Adaptive Rec program and having Disabilities in Action help with it.
- Ruby Blascyk spoke in favor of keeping the Adaptive Rec program.
- Shannon Bryant spoke in favor of keeping the senior meal program free.
- Jerry Holman spoke in favor of keeping the Adaptive Rec program.
- Brandi Kaufmann spoke in favor of keeping the Adaptive Rec program.
- Taylor Kohler spoke in favor of keeping the Adaptive Rec program.
- Jeff Bell spoke in favor of keeping the Adaptive Rec program.
- Katherine Ballard (through a sign language interpreter) spoke in regards to the importance of helping those with special needs, and keeping the senior meals free.
- Welton Robinson spoke in favor of keeping the senior meals free.

- Jerry Smith stated he always gets a recording when he calls 2-1-1 and hopes that can be fixed. Also stated that he thinks City employees would not suffer from a 5% salary reduction to help the budget shortfalls.
- Tammy Sanford spoke in favor of keeping the Adaptive Rec program.
- LouAnne Chastain spoke in favor of keeping the Adaptive Rec program.
- Chantee Fleming spoke in favor of keeping the money already approved for parks updates as it is.
- Niccolus Moses understands the need of the Adaptive Rec program but hopes the money can come from somewhere other than the money budgeted for parks upgrades,
- · Chris Daughtry encouraged Council not to take away money from any recreation department.
- Candy Ice spoke in favor of keeping the Adaptive Rec program.

With no other speakers coming forward, the public hearing was closed.

Mayor Williams moved to approve the item as presented with the following changes:

- Funding for Adaptive Recreation Services is removed for the remainder of FY 2021, and the City Manager is directed to identify and negotiate the divestment by the City and assumption of the program by a trusted nonprofit entity.
- A fee in the amount of \$2.00 is to be charged for Senior meals. The implementation will be delayed until a scholarship program can be established.
- A fee in the amount of \$25 is to be charged to league sport players as a facility use charge, per player, per season. Those players who reside in the corporate boundaries of the City of Abilene shall be charged a discounted rate of \$20. The implementation will be delayed until a scholarship program can be established.
- The funding set aside for Park improvements shall be reduced by \$50,200 and the same amount shall be appropriated for Senior meals.
- The City Manager will make travel and training cuts, as needed.

Mayor Pro-tem Price seconded the motion; motion carried.

- David Swart stated that the only business that affects him is Coca-cola. Thinks we are ripe in the picking for new business and we should have started on the hotel project now since it's a good time.
