The City Council of the City of Abilene, Texas met in Regular Session on January 14, 2021, at 8:30 a.m. in the Council Chambers, 555 Walnut St. Mayor Anthony Williams was present and presiding with Mayor Pro-tem Shane Price, Deputy Mayor Pro-tem Jack Rentz, and Councilmembers Donna Albus, Weldon Hurt, Kyle McAlister, and Travis Craver. Also present were City Manager Robert Hanna, City Attorney Stanley Smith, and City Secretary Shawna Atkinson.

David Swart - stated that this is a good move. Seems like one dealership always get the police vehicle bids, and the Parks Department has a hodge-podge of different makes. He thinks it is a good thing to have this, so local bidders can get in on it.

Michael Rice, Assistant City Manager, presented the item. The City's contractor for receiving & processing cardboard and paper products has placed the City on notice that they will no longer be able to provide this service after January 31, 2021. This discussion is to determine the Council's desire for Abilene's recycling program in the future.

Mayor Williams opened the public hearing. The following addressed the Council:

David Swart - stated that he didn't like when plastics went away, because it is convenient to buy bottled water, but then you have to do something with the bottles afterwards. The newspaper recycling at United was convenient. Mr. Swart is glad to see we are not pulling the recycling centers completely. He thinks this is something the DCOA should be able to assist with and urged staff to reach out to them for help.

With no other speakers coming forward, the public hearing was closed.

Council and Staff discussed various options to move forward with recycling. Robert Hanna, City Manager stated he would like 90 days to do an analysis and bring back different options to Council. Mr. Hanna wants to look at all the materials, not just cardboard.

This item was for discussion only. No votes or action were taken at this time.

Adoption of the item would rezone the above referenced property from a combination of Manufactured/Mobile Home (MH) and General Commercial (GC) to Planned Development (PD) District, allowing occupancy by recreational vehicles and vacation travel trailers as well as mobile and manufactured homes.

Mayor Williams opened the public hearing. With no speakers coming forward, the public hearing was closed.

Mike Warrix, Director of Planning & Development Services, presented the item. Adoption of the item would rezone rezone the above referenced property from Agricultural Open Space (AO) to Neighborhood Retail (NR) District, to allow for a parking lot.

Mayor Williams opened the public hearing. The following addressed the Council:

Tal Fillingim, agent with Jacob & Martin - stated that the request was to rezone only a portion, but understands doing the whole area. There is buffering requirements in the LDC and they will adhere to them. They do not expect any more development other than the parking lot, and cars will park facing north and south.

Mike Warrix, Director of Planning & Development Services, presented the item. Adoption of the item would rezone the above referenced property from Residential Single-Family Patio Home (PH) to a Residential Medium-Density (MD) District.

Mayor Williams opened the public hearing. The following address the Council:

Tal Fillingim, agent with Jacob & Martin - stated the request is to go back to MD. The owners decided to go back to this original plan and apologized for going back and forth.

With no other speakers coming forward, the public hearing was closed.

Mayor Williams, Councilmember Price and Councilmember McAlister had a conflict of interest on this item and abstained from voting. Conflict of Interest Affidavits were filled out before the meeting and filed with the City Secretary's office. Mayor Williams, Mayor Pro-tem Price and Councilmember McAlister left the room during this discussion and Deputy Mayor Pro-tem Rentz presided.

Mike Warrix, Director of Planning & Development Services, presented the item. Adoption of the item would rezone the above referenced property from Residential Medium-Density (MD) to a College University (CU) District.

Deputy Mayor-tem Rentz opened the public hearing. The following addressed the Council:

 Kendra Hanfeld with Parkhill, Smith and Cooper, Inc – stated that ACU has already gained ownership of the property and intends to use it for their education programs.

Kendra Hanfeld with Parkhill, Smith and Cooper, Inc - stated that this is really a cleanup, as the land was never swapped. They will be combining it with the rest of the property.

- David Swart stated this is a rough election year and has lost faith in the ballot box. When they check your ID and names don't match with the voter ID card, he questions if his vote actually counted. Mr. Swart requested to publish the senior menu online and it is still not there. The \$2.00 charge is starting in February.
- Samuel Garcia stated he is shocked that Councilmember McAlister said it is great for the DCOA to have a country club membership. Mr. Garcia spoke about receipts from dinners and thinks the DCOA needs more oversite. City employees don't spend money at the country club so he doesn't understand why this is allowed. He stated that Jack Rich is being appointed to board for the 3rd time, and that there are no Hispanics on that board. Mr. Garcia thinks he is overly qualified to be appointed instead of Mr. Rich.

With no other speakers coming forward, the public comment period was closed.
