CITY COUNCIL MEETING January 28, 2021 at 4:30 p.m.

CITY COUNCIL OF THE CITY OF ABILENE, TEXAS COUNCIL CHAMBERS, CITY HALL

The City Council of the City of Abilene, Texas met in Regular Session on January 28, 2021, at 4:30 p.m. in the Council Chambers, 555 Walnut St. Mayor Anthony Williams was present and presiding with Mayor Pro-tem Shane Price, Deputy Mayor Pro-tem Jack Rentz and Councilmembers Donna Albus, Weldon Hurt, Kyle McAlister and Travis Craver. Also present were City Manager Robert Hanna, City Attorney Stanley Smith, Deputy City Secretary Kaitlin Richardson, and various members of the City staff.

Robert Hanna, City Manager, presented the item. Adoption of the item would approve the appointment of Marcus Dudley as the Chief of Police, effective January 1, 2021.

City Manager Hanna read a letter from the Nick Metts, retired Police Chief in Aurora, Colorado, in regards to Marcus Dudley's professional character. Melvin Martin, former Chief of Police and on the selection panel, spoke about Chief Dudley and the selection process.

Mayor Williams opened the public hearing. The following addressed the Council:

14. Oath of Office for Police Chief Marcus Dudley

Chris Hobbs, Management Assistant to the Chief of Police, administered the oath of office to Police Chief Marcus Dudley.

Chief Dudley spoke briefly about his move to Abilene, his family and thanked the community for their kind words.

PUBLIC COMMENTS

Mayor Williams opened the public comment period. The following addressed the city council:

- David Swart stated he saw that Mayor Williams withdrew his name from the City Manager position in Washington. He received a letter from the Rose Park Senior Center about the new meal pricing, and suggests changing it to a whole dollar amount, so that staff does not have to carry coins for change. Mr.
 Swart also spoke about Challenger Shuttle in 1986.
- Samuel Garcia stated that he found more receipts from the DCOA in regards to spending tax payer money frivolously. Mr. Garcia stated that this time it was the CEO of the DCOA and the City Manager that dined at Perini's Ranch House and used tax dollars to pay for their meal. Mr. Garcia is appalled that they spent tax payer dollars on an out of state vendor to monogram the DCOA's items, when Abilene has various vendors to choose from. Mr. Garcia also stated that he doesn't understand why race was brought up at the previous meeting when he spoke.

With no other speakers coming forward, the public comment period was closed.
