# CITY COUNCIL OF THE CITY OF ABILENE, TEXAS COUNCIL CHAMBERS, CITY HALL

The City Council of the City of Abilene, Texas met in Regular Session on April 22, 2021, at 4:30 p.m. in the Council Chambers, 555 Walnut St. Mayor Anthony Williams was present and presiding with Mayor Pro-tem Shane Price, Deputy Mayor Pro-tem Jack Rentz and Councilmembers Donna Albus, Weldon Hurt, Kyle McAlister and Travis Craver. Also present were City Manager Robert Hanna, City Attorney Stanley Smith, City Secretary Shawna Atkinson, and various members of the City staff.

7. Resolution: Receive a Report, Hold a Discussion and Public Hearing, and Take Action on Approving the Annual Budget of the Abilene Convention Center Hotel Development Corporation [ASSIGNED RESOLUTION NO. 51-2021]

The item was pulled by Bob Thomas, citizen.

Having pulled the item, Bob Thomas stated that we are giving the City Manager what the media calls "small powers" concerning the hotel, but when talking about \$23 million, it's not a small amount. It is 27% of the income of Abilene. Mr. Thomas asked what is changing here that was not originally agreed upon.

Robert Hanna, City Manager, addressed Mr. Thomas's concerns and stated that this is granting him the responsibility only. Council still has final authority.

With no other speakers coming forward, the public comment period was closed.

Councilmember McAlister moved to approve the item as presented. Councilmember Albus seconded the motion; motion carried.

11. Ordinance (First Reading) Z-2021-06: Receive a Report, Hold a Discussion and Public Hearing, and Take Action on a request from all five owners of the subject properties, represented by Jacob & Martin LLC, to amend terms and conditions of Planned Development District Number 82 (PD 82) specifically as they affect certain commercial properties located directly north of Lone Star Drive and east of Loop 322, to allow use and development in compliance with requirements of General Retail (GR) zoning, instead of specific uses and standards now required by PD 82

#### The item was pulled by Mayor Pro-tem Price

Having pulled the item, Mayor Pro-tem Price stated that from what he has read we are taking the PD requirements and reducing to a GR, but still within the parameters of a PD. In 5-10 years someone who is looking at this will have to do research to figure this out. Mayor Pro-tem Price asked if we could change it to a straight GR zoning.

Mike Warrix, Director of Planning and Development Services, addressed Mayor Pro-tem Price's concerns stating that this PD consists of 2 tracts. The requester is only proposing this for tract 1. The requester is wanting to eliminate the permitted uses originally adopted as part of the PD, and replace those with basic general retail permitted uses. There is no distinguishing factor between this and GR, but it is still a PD though. The applicant wants to keep the two tracts together in the PD.

Mayor Pro-tem Price has asked staff to reach back out to the applicant to see if they are still wanting to do this before the final hearing.

Mayor Williams opened the public hearing. With no speakers coming forward, the public hearing was closed.

Mayor Pro-tem Price moved to approve the item as presented. Deputy Mayor Pro-tem Rentz seconded the motion; motion carried.

Robert Hanna, City Manager, presented the item. Adoption of the item would create a task force for the Mayor's Entertainment District. This task force will have 7 voting members that will study and review options to create a downtown entertainment district.

David Swart – stated that in Las Vegas you can go out onto the strip with open containers, with the exception of glass. Mr. Swart suggested more trash containers and a boundary at North 8<sup>th</sup>, South 7<sup>th</sup>, Treadaway, Hickory and Butternut. This would encompass most businesses that would benefit from this. Mr. Swart stated this is an opportunity to expand our city.

With no other speakers coming forward, the public hearing was closed.

Councilmember Hurt moved to approve the item as presented. Councilmember Craver seconded the motion; motion carried.

### **PUBLIC COMMENTS**

Mayor Williams opened the public comment period. The following addressed the city council:

- David Swart stated that there is nothing on the city calendar for the Convention Center, and that the public would attend more events if they knew about them. Mr. Swart stated that the Abilene Reporter News had an article about the individuals running for Council and one of them mentions a deficit in the City's budget, and as far as he knows, only the feds can have a deficit. Mr. Swart thinks we need to see what can be done about getting Fire Station 9 moving forward, since Station 2's service area is 25 miles and that is too large. The Governor said he would wear a cheese head for the new Great Lakes Cheese Factory ribbon cutting, so Mr. Swart suggested that Council should too.
- Delores Moore wanted to thank Misty Mayo, City staff, and the State for everyone who had a part in bringing in Great Lakes Cheese to Abilene. She thinks this was an exciting announcement, and likes that they look at organizations that are viable and have longevity. Ms. Moore thinks this company is going to offer something to our citizens and show we have good paying, long range jobs.
- Kelsey Mangra stated on behalf of the Chamber executive board, that they wanted to show their enthusiasm and support of Great Lakes Cheese locating to Abilene. Misty Mayo and her team at the DCOA have done an incredible job in creating a partnership with them and creating 500 jobs. Ms. Mangra stated that this investment would not only stimulate small businesses but have a huge impact on schools and property values. She thinks we should be proud of a company with a family business culture.
- Gary Grubbs chairman of the AIF board and wanted to thank the Council and the DCOA for all the hard work with Great Lakes Cheese. AIF and Develop Abilene are working on business retention and expansion to help create, equip and grow businesses. Mr. Grubbs is committed to the future of Abilene and proud to be a part of it.
- John Beckham stated he wanted to thank Council and the City Manager, and that he is gracious to the business community here. Mr. Beckham stated that the hiring of Misty Mayo was undoubtedly the highlight of his board service on the DCOA. He thinks Abilene is poised for great things and it's time for it to shine.

• Samuel Garcia – stated he got a different take on this announcement and is very disappointed that it was done during a special called meeting, as it was a little surprising to him. He stated that the success will happen when people actually get these jobs and there is longevity. Mr. Garcia stated that it looks like a big portion of the factory will be built in Eula ISD and wants to know what Abilene ISD will get in property taxes. He is wanting to know how many of the jobs are going to be production jobs and what is the median salary.

With no other speakers coming forward, the public comment period was closed.
