

SPECIAL CALLED MEETING

**CITY COUNCIL OF THE CITY OF ABILENE, TEXAS
COUNCIL CHAMBERS, CITY HALL**

The City Council of the City of Abilene, Texas met in Special Session on May 10, 2021, at 1:30 p.m. in the Council Chambers, 555 Walnut St. Mayor Anthony Williams was present and presiding with Mayor Pro-tem Shane Price, Deputy Mayor Pro-tem Jack Rentz, and Councilmembers Donna Albus, Weldon Hurt, Kyle McAlister, and Travis Craver. Also present were City Manager Robert Hanna, City Attorney Stanley Smith, City Secretary Shawna Atkinson, and various members of the City staff.

Councilmember Travis Craver delivered the invocation and led the Pledge of Allegiance to the Flags of the United States of America and the State of Texas.

2. Resolution: Canvassing the Returns and Declaring the Results of the General Election Held in the City of Abilene on May 1, 2021
[ASSIGNED RESOLUTION NO. 58-2021]

Shawna Atkinson, City Secretary, presented the item. The election results reported Shane Price received 75.91% of the votes for City Council Place 1, and Lynn Beard received 82.59% of the votes for City Council Place 2. Both are therefore duly elected.

Mayor Williams opened the public hearing. With no speakers coming forward, the public hearing was closed.

Deputy Mayor Pro-tem Rentz moved to approve the item as presented. Mayor Pro-tem Price seconded the motion; motion carried.

Councilmember Hurt moved to approve the appointment of Councilmember Kyle McAlister as Mayor Pro-tem and Councilmember Travis Craver as Deputy Mayor Pro-tem. Councilmember Albus seconded the motion; motion carried.
