CITY COUNCIL OF THE CITY OF ABILENE, TEXAS COUNCIL CHAMBERS, CITY HALL

The City Council of the City of Abilene, Texas met in Regular Session on May 27, 2021, at 4:30 p.m. in the Council Chambers, 555 Walnut St. Mayor Pro-tem Kyle McAlister was present and presiding with Deputy Mayor Pro-tem Travis Craver, and Councilmembers Shane Price, Lynne Beard, and Weldon Hurt. Also present were City Manager Robert Hanna, City Attorney Stanley Smith, City Secretary Shawna Atkinson, and various members of the City staff. Not present were Mayor Williams and Councilmember Albus.

EXECUTIVE SESSION

Tim Cass, Assistant Director of Fleet Services addressed Councilmembers questions, stating that in 2023 the other two will be discontinued and that there is no problem staffing these machines.

18. Ordinance (First Reading): Receive a Report, Hold a Discussion and Public Hearing, and Take Action on Amending Budget Ordinance No. 31-2020 to Include Updated Staffing Levels for the Police Department

Having pulled the item, David Swart stated his concerns over this change and that the City should consider a corporal position for the department instead, as peer cities have that position. Creating that position would give tenured patrol officers a chance for a little seniority if they don't want to go straight to sergeant. Mr. Swart also questioned where the funding is coming from for this.

Chief Dudley addressed David Swart's question and concerns stating that they are not asking for an exact 1 to 1 replacement. Staff is currently going through an organizational restructuring that will require them to divide the responsibilities that fall under patrol and investigations, to create a separate support services division, and need an assistant chief to cover that new department.

With no other speakers coming forward, the public hearing was closed.

Don Green, Transportation Director, presented the item. Adoption of the item would approve the land use plan for the Abilene Regional Airport. Mr. Green introduced Kate Alvarez, Airport Business Development Manager, who presented the complete land use plan.

Mayor Pro-tem McAlister opened the public hearing. The following addressed the Council:

• David Swart – stated that this is a wonderful vision for future generations to enjoy. He hopes to see a well-known budget carrier at our airport though, since Southwest Airlines flies over Abilene all the time anyway. The vision video reminded him of the Phoenix and Midland airport. He stated that it will be hard coming out of COVID right now and money being tied up, but maybe someday this would be achievable.

Stanley Smith, City Attorney, presented the item. Adoption of the item would amend the Land Development Code by changing the process for street and alley abandonments and closures.

PUBLIC COMMENTS

Mayor Pro-tem McAlister opened the public comment period. The following addressed the city council:

• David Swart – stated that Monday is Memorial Day, for all the soldiers that did not come home, and to remember that when celebrating at your BBQ. He also stated that it is energy star weekend, so if you need energy efficient products, you will get a tax break. Mr. Swart stated that in 2018 he got a library card and in the last thirty months it has been deactivated four times, and he doesn't understand why it keeps happening. He gave an example of when he went to the Mockingbird library recently to print something and it took five minutes of trying his card before realizing it was deactivated, and he didn't get to finish printing before the computers turned off for the day. He stated his frustration in this process.

With no other speakers coming forward, the public comment period was closed.
