- 1. WELCOME AND INTRODUCTIONS. Having a quorum of the board, Board President Peter Lauve called the meeting to order in the Frontier Texas! Board Room, 625 North First Street, Abilene, Texas.
- 2. **REVIEW FINANCIAL STATEMENT OF POSITION.** Accounting Coordinator presented the May Statement of Financial Position. The Venue Tax collections are above expected levels due to the firefighters staying in Abilene. The admission revenues are below budget. Frontier Texas! is admitting the firefighters free of charge in recognition of their efforts.
- 3. CONSENT AGENDA. The May Attendance and Revenues report was removed from the Consent Agenda for corrections. There was a motion to accept the remaining Consent Agenda items as presented. The motion was seconded and carried.

- **a. - **b. Fundraising Committee.** Committee Co-chair, Kim Snyder reported the committee has 18 teams playing, the margarita contest, and Mark Powell's band as entertainment. This year, a buffalo gun shooting contest has been added to the event.
- 5. **EXECUTIVE DIRECTOR'S REPORT.** Executive Director, Jeff Salmon distributed a handout detailing recent Frontier Texas! marketing and events. Mr. Salmon reported Frontier Texas! recently held two summer camps and a new exhibit on Albany opened in the Frontier Gallery. Frontier Texas! has been receiving unexpected motor coach tours that are helping boost attendance numbers. Additionally, a new contract for electricity will go into effect with Priority Power soon. Mr. Salmon distributed a handout with the proposed exhibit re-development features. Mr. Salmon took the board members through the exhibit.
