Regular Meeting

1. Call to order and swearing of new councilmembers

Workshop

1. Discussion and possible action on the following:

a) What is our mission?

c) Marketing Subcommittee recommendation re: sponsorships on myfitnessabilene.com

The Marketing Subcommittee recommendation regarding sponsorships on the myfitnessabilene.com was tabled. The Subcommittee will meet with InFocus Digital in an effort to determine the best approach to take for securing sponsorships for the website.

d) Solicitation packet used for Mayor's 5K

Joy Hedges presented the solicitation packed used for the 2010 Mayor's 5K She noted that the date for the 2011 Mayor's 5K has tentatively been set for April 9, 2011.

e) Advertising campaign to market myfitnessabilene.com

The Mayor's Council on Physical Fitness website, myfitnessabilene.com is currently being administered by InFocus Digital. Kelley Messer, City Legal staff, informed the Council that the InFocus Digital contract expires August 2010.
