Lease Agreement opportunity for the Parks Department with Chick-Fil-A. The Chick-Fil-A location on Southwest Drive is a traffic concern for the City, probably a concern for Chick-Fil-A too. Hanna has worked with Chick-Fil-A Real Estate to identify a City owned parcel that Chick-Fil-A would relocate to. This would be a Lease Agreement with Chick-Fil-A for an initial term of 15 years, 5 null terms of 5 years a piece, 40 year total term, with the opportunity to renew again for another 40 year term. Revenue from this lease must be spent within the Parks & Recreation System per the charter. All the totals added up is about \$7 Million in revenue for the Parks Department over the term of the agreement of 40 years.. This funding is not Tax revenue generated, it is generated through an alternative revenue source, such as a commercial lease.
