## PARKS & RECREATION BOARD MEETING

# February 20, 2024

Invocation: Leigh Black gave the invocation.

**Public Comment: None** 

**Service Award:** Richard Rodgers presented Scott Wylie with his service award for 5 years of service.

Acceptance of Minutes from December 19, 2023: Gary Grubbs moved the minutes to be approved. Leigh Black seconded. With all in favor, the motion carried.

**Baseball/Softball Expansion Project:** Lesli Andrews discussed the changes in baseball and softball and being approached for updates and new facilities. Lesli talked about a contract with La Terra Studio to develop a master plan for future needs. Lesli asked the Parks and Recreation Board to form a task force to help with recommendations for the City Council.

**Seniors Report:** Bobby Brown gave the Seniors Report. Bobby spoke about the March Hoops bracket competition starting on March 18th. Bobby stated a Food & Nutrition program will be hosted by Texas A&M,on the 1st and 3rd Thursday of the month. Bobby talked about the Saint Patrick's Day party on Friday March 15th at 10am, with refreshments and prizes for games.

Jesse informed the board of the loss of Henry the maned wolf and Hunfredo the ocelot and also the birth of a prehensile tailed porcupette and a maned wolf pup.
