1. CALL TO ORDER

The Planning and Zoning Commission convened in a regular meeting. Melissa Farr took the roll call noting the following commissioners present:

2. INVOCATION

Mr. Calk delivered the invocation.

Mr. Rosenbaum announced the first zoning item on the agenda, Z-2019-08, was withdrawn from consideration by the applicant.

3. APPROVAL OF MINUTES FOR THE PREVIOUS MEETING

There being no deletions, no additions, and no corrections, Reverend Lankford moved to <u>approve</u> the minutes for the planning and zoning commission special meeting of March 5, 2019. Mr. Smith seconded the motion. The motion to approve prevailed by the following vote:

- a) FP-2218: Hampton Hills, Section VI, Abilene, Taylor County, Texas
- b) PP-1119: Preliminary Plat of Highland Farms, Section 1, Taylor County, Texas

Mr. Rainbow presented the plats. Mr. Rosenbaum opened the public hearing. Seeing no one present and desiring to be heard, the public hearing was closed.

Mr. Smith moved to <u>approve</u> the submitted plats. Mr. Calk seconded the motion. The motion to approve prevailed by the following vote:

5. ZONING

- a. *WITHDRAWN FROM CONSIDERATION* Z-2019-08 Public hearing and possible vote to recommend approval or denial to City Council on a request from Drcsmiles, LLC, agent Kevin Phillips, to amend PD96A (Planned Development 96A) to allow outdoor storage, storage of recreational vehicles, and also mini-storage warehouses. Proposed uses would be on the rear 5.35 acres of the 8.35 acre site at 5333 Buffalo Gap Road, being Lot 102 in Block A of Mindy Morris Subdivision, Abilene, Taylor County, Texas
- b. **Z-2019-09** Public hearing and possible vote to recommend approval or denial to City Council on a request from the Abilene Forrest Hill, LLC, agent Jacob & Martin Engineering, to rezone property from Residential Single-Family (RS-8) zoning to a mixture of Residential Single-Family (RS-6) and Multi-Family (MF) zoning districts on all or part of 42 acres out of T.C. Garner Survey in Abilene, Taylor County, Texas, and bordering east side of Old Forrest Hill Road, south from Forrest Hill Road.

Mr. Brad Stone presented this request.

Mr. Rosenbaum opened the public hearing. Mr. Clayton Farrow spoke in favor of this request stating the owner's intent is to construct duplexes. After speaking with the owner, they would like to revise the request from MF to MD zoning. Mr. Zack Rainbow confirmed City Staff agreed MD would be a preferable zoning request.

Those who did not speak in favor of the MF and MD zoning districts were:

Mr. Michael Thornton stated he was not in opposition toward development, but expressed concern of transportation accessibility.

Mr. Jon Caudle spoke in opposition on behalf of the homeowners in Mesa Ridge Villas to share their concern of increased traffic on Phoenix Drive.

Mr. Rosenbaum closed the public hearing.

The public hearing was reopened to allow Mr. Farrow to state consideration of connecting to Old Forrest Hill.

The public hearing was closed.

Property owners within a 200-foot radius were notified of this request. There were no (0) responses received in favor with five (5) in opposition.

PLANNING STAFF RECOMMENDATION: Staff recommends approval of the request.

Discussion included: Responsibility of parties to repair each half of road, development of Forrest Hill Road, traffic patterns

Mr. Bixby moved to <u>approve</u> the request to change from Residential Single-Family (RS-8) zoning to a mixture of Residential Single-Family (RS-6) and Medium Density (MD). Reverend Lankford seconded the motion. The motion to approve prevailed by the following vote:

b. **Z-2019-10** Public hearing and possible vote to recommend approval or denial to the City Council on a request from The Well Abilene, to rezone property from Light Industrial (LI) zoning to Central Business (CB) zoning district on property at 709 North 2nd Street, encompassing 0.554 acre out of Blind Asylum Lands Section 36 in Abilene, Taylor County, Texas

Mr. Jared Smith presented this request. The request is a zone change from Light Industrial (LI) to Central Business (CB).

Mr. Rosenbaum opened the public hearing. Seeing no one present and desiring to be heard, the public hearing was closed.

Property owners within a 200-foot radius were notified of this request. Two (2) responses were received in favor with none (0) in opposition.

PLANNING STAFF RECOMMENDATION: Staff recommends approval of the request.

Mr. Calk moved to <u>approve</u> the request. Mr. Noonan seconded the motion. The motion to approve prevailed by the following vote:
