- Utilities must be relocated or City staff must be furnished with documentation from each affected utility provider that suitable payment has been made for the timely relocation of utilities.
- City staff must be furnished with a title opinion or title commitment issued by a title insurance company confirming ownership of the property.

**FP-1321:** Receive a Report, Hold a Discussion and Public Hearing, and Take Action on a plat for Lot 1, Block A of Industrial Junction Additions, Abilene, Taylor County, Texas Mr. Jared Smith presented the plats.

Staff recommends approval with the following conditions:

- Construction plans must be submitted to and approved by the City Engineer.
- All public improvements must be completed and inspected for acceptance or financial guarantee must be provided securing the obligations of all public improvements.
- City staff must be furnished with a title opinion or title commitment issued by a title insurance company confirming ownership of the property.
