AN ORDINANCE DESIGNATING ELECTION PRECINCTS
AND VOTING PLACES IN THE CITY OF ABILENE FOR
MUNICIPAL ELECTIONS.

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE
CITY OF ABILENE:

Section 1. That said city be and the same is hereby
divided in five election precincts, hereinafter numbered, follow-
ed by the names of the buildings or voting places therein where
the voters residing in such precincts shall cast their votes in
all municipal elections held in said city, unless otherwise order-
ed by the Board of Commissioners, said precincts being described
by metes and bounds as follows, towit:

PRECINCT NO. 1 TAYLOR COUNTY COURT HOUSE

Commencing with intersection of East City Limits with
the T & P R. R., Thence South with said City limits following
same with its meanderings around to a point in the center of
Sycamore Street, Thence North with the center line of Sycamore
Street to the North property line of South 14th Street; Thence
West with the North property line of South 14th Street to a point
in the center line of Elm Street, thence North with the center
line of Elm Street to the T & P R. R., Thence East with said R. R.
to the place of beginning.

PRECINCT NO. 2 -- FIRE STATION 5TH & BUTTERNUT STREETS

Commencing at a point on the T & P R. R. directly North
of the Center line of Elm Street; Thence South with the center
line of Elm Street to the North property line of South 14th Street,
Thence East with the North property line of South 14th Street to
a point directly North of the center line of Sycamore Street;
Thence South with the center line of Sycamore Street to City
Limits; Thence West with said City Limits line following same with
its meanderings to a point on a straight line with the center of
Amarillo Street; Thence North with the center line of Amarillo
Street to the T & P R. R., Thence East with said R. R. to the
place of beginning.

PRECINCT NO. 3 -- WOMAN'S BUILDING FAIR PARK

Commencing at a point on the T & P R. R. directly North
of the center line of Amarillo Street, Thence South following the

center line of said street to the City limits; Thence West with said city limits line following same with its meanderings to the Southwest corner of said City limits; Thence Northward with said City limits with its meandering to the T & P R.R., Thence East with said R. R. to the place of beginning.

PRECINCT NO. 4 -- SHELTON WEBB MOTOR CO., NORTH 1ST AND ORANGE STREETS

Commencing at a point on the T & P R.R. directly South of the center line of Hickory Street; Thence North with the Center line of Hickory Street to a point where same intersects city limits; Thence West with said City limits following same with its meanderings to the Northwest corner of said City Limits, Thence South with said City limits with its meanderings to the T & P R.R.; Thence East with said R. R. to the place of beginning.

PRECINCT NO. 5 -- CENTRAL FIRE STATION, NORTH 4th & CEDAR STREETS

Commencing with intersection of East City Limits with the T & P R.R., Thence North with said city limits following same with its meanderings to a point where same intersects center line of Hickory Street, Thence South with the center line of Hickory Street to the T & P R.R., Thence East with T & P R.R. to place of beginning.


Section 2. That if for any reason it becomes impracticable to hold an election at any of the voting places herein named, the Mayor may name another voting place for such precinct, in lieu of such place, which he deems impracticable.

Section 3. This ordinance shall not be held to prohibit the Board of Commissioners from ordering municipal elections to be held at other voting places, and designated territory of said city, as they may see fit.

Passed at its first reading this 3 day of May, A. D. 1940, all commissioners voting "aye".

Passed on its second and final reading this the 10 day of May, A. D. 1940, all commissioners voting "aye".
