

AN ORDINANCE ANNEXING CERTAIN PORTIONS OF THE McMURRY COLLEGE AREA TO THE CITY OF ABILENE.

Whereas, written applications have been made to the Board of Commissioners of said City to annex the hereinafter described territory to the City of Abilene, which is adjoining and contiguous to the corporate limits of said City, which applications have been signed by certain persons, which applications have been proved by certain affidavits attached to said petitions, ^{to be} ~~as~~ the genuine signatures ~~of the persons~~ ^{of the persons} whose names are signed thereto; the said Board of Commissioners finds that said petitions have been signed by a majority of the voters ~~residing in said territory,~~ qualified to vote for members of the Legislature of the State of Texas, who reside in the territory sought to be annexed and are favorable to said annexation, said territory being portions of of the Continuation of the Campus Addition, McMurry Park Addition, Boulevard Heights Addition and Sayles subdivision of 53.5 acres of the B. Austin Survey No. 92, the territory to be annexed being a solid block of land, therefore,

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF ABILENE: That the following described territory be and the same is hereby annexed and included within the corporate limits of said City of Abilene so as to become an integral part thereof, and the territorial limits of said city are hereby changed so as to include said territory within said City, the territory hereby annexed being described by metes and bounds as follows, to-wit: BEGINNING at the Northeast corner of Ave. E where it intersects the South line of South Fourteenth Street, as shown on the map or plat of the Continuation of the Campus Addition; thence south with the East line of said Avenue E to a point where the East line of Avenue E intersects with the North line of Forest Drive; Thence East along the North line of Forest Drive to a point where it intersects the old Buffalo Gap Road; Thence along the west line of the old Buffalo Gap Road to a point where the Northwest line of the old Buffalo Gap Public Road intersects the south boundary line of South Fourteenth Street; Thence west along the south line of South Fourteenth Street to a point where the east line of McMurry Campus intersects with south Fourteenth Street; Thence South along the east line of McMurry Campus to Hunt Street; Thence west

along the south line of Hunt Street to the southwest corner of McMurry Campus; Thence North along the west line of McMurry campus to South Fourteenth Street; Thence west along the south line of South Fourteenth street to the place of beginning.

It is further ordained by said Board of Commissioners that the annexed territory be placed in and included in Zone "B", Dwelling District and subject to the restrictions as set out and defined in "THE ZONING ORDINANCE OF THE CITY OF ABILENE OF 1946"
