

"AN ORDINANCE AMENDING AN ORDINANCE PASSED ON ITS FIRST READING AUGUST 8TH, 1947, *here* ENTITLED " AN ORDINANCE ANNEXING TO THE CITY OF ABILENE, CERTAIN TERRITORY BOUNDED BY THE NORTH LINE OF LOT 2, BLOCK B, ANDERSON SUBDIVISION AND THE SOUTH LINE OF LOT 5, BLOCK B, ANDERSON SUBDIVISION, AND THE OLD CEDAR GAP ROAD AND VINE STREET BY CHANGING THE NORTH BOUNDARY LINE OF SAID ANNEXED TERRITORY FROM SOUTH 14TH STREET TO THE NORTH LINE OF LOT 2, BLOCK B, ANDERSON SUBDIVISION, AND CHANGING THE SOUTH LINE FROM SOUTH 20TH STREET TO THE SOUTH LINE OF LOT 5, BLOCK B, ANDERSON SUBDIVISION, AND ZONING THE SAME."

Whereas, a petition has been presented to the Board of Commissioners asking for the annexation of certain property contiguous and adjacent to said city bounded by the North line of Lot 2, Block B, Anderson Subdivision and the South line of Lot 5, Block B, Anderson Subdivision and the Old Cedar Gap Road and Vine Street; and, whereas, said petition has been signed by a majority of the persons residing in said territory who are qualified to vote for members of the Legislature of the State of Texas, which application has been duly proved by affidavit of one or more persons that the signatures are genuine as required by Section 4 of the City Charter; and whereas an Ordinance was passed on its first reading on the 8th day of August, 1947, bearing the following Caption;

"ORDINANCE ANNEXING TO THE CITY OF ABILENE, CERTAIN TERRITORY BOUNDED BY SOUTH 14TH AND SOUTH 20TH AND THE OLD CEDAR GAP ROAD AND VINE STREETS"

And whereas, there was a mistake in the description of the Territory, as described in said Caption, which was amended by the Board of Commissioners of said City on August 22nd, 1947, by changing the Caption thereof to the Caption of this Ordinance;

Therefore, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF ABILENE: That said territory be and the same is hereby annexed to said city, being described by metes and bounds as follows:

"Beginning at the southwest corner of Lot 8, Block 6, Fairmont Addition to the City of Abilene, said point being in the East property line of Vine Street; thence North along the East property line of Vine Street, said line being the present City Limit Line, to the Northwest Corner of Lot 8, Block 2, Fairmont Addition to the City of Abilene; thence West across Vine Street to the Northeast Corner of Lot 8, Block 2, McMurry Park Addition to the City of Abilene; thence South along the West property line of Vine

Street to a point in the West property line of Vine Street and opposite the Southwest Corner of Lot 5, Block B, Andersons Addition to the City of Abilene; thence East across Vine Street to the Southwest Corner of Lot 5, Block B, Andersons Addition to the City of Abilene; thence East along the South property line of Lot 5, Block B, Andersons Addition to the City of Abilene to the Southeast Corner of Lot 5, Block B, Andersons Addition, said point being in the West line of a five foot strip that is now in the City Limit; thence East across said five foot strip and across the Old Cedar Gap Road to a point in the East property line of the Old Cedar Gap Road, said point being opposite the Southeast Corner of Lot 5, Block B, Andersons Addition to the City of Abilene; thence North along the East property line of the Old Cedar Gap Road to a point in the East line of the Old Cedar Gap Road opposite to the Southeast Corner of Lot 1, Block 5, Fairmont Addition to the City of Abilene, said point being in the present City Limit of the City of Abilene; thence West along the present City Limit of Abilene across said five foot strip and across the Old Cedar Gap Road to the Southwest corner of Lot 8, Block 6, Fairmont Addition to the City of Abilene, the point of beginning. Containing 23.3 acres, more or less.

Said Territory hereby annexed is placed in Zone "B" according to the Zoning Ordinance of the City of Abilene of 1946, and the City Engineer is hereby authorized and directed to indicate said zoning on the map of said City.

This ordinance shall be in full force and effect from and after the time of its final passage and publication.

Notice of the passage of this ordinance shall be given by publishing the caption hereof, as ~~is~~ provided in the amendment to Art. 1013, Revised Civil Statutes of Texas 1925, by H. B. 565, 50th Legislature.

Passed on its first reading the 8th day of August 1947.

After said passage, a notice of the time and place when and where said ordinance would be given a public hearing and considered for final passage, was published in the Abilene Reporter-News, a daily newspaper of general circulation in the City of Abilene, the first publication being at least one week prior to the time advertised. After such opportunity for the public to be heard, said ordinance was amended on August 22nd, 1947.

A notice of the time and place when and where said amended ordinance would be further considered for its final passage was published in the Abilene Reporter-News, the first publication being at least three days prior to the time of public hearing on said amended ordinance; and said ordinance as amended was passed on its second and final hearing on the 25<sup>th</sup> day of August, A.D. 1947.
