

ORDINANCE NO. 275

AN ORDINANCE ANNEXING BLOCKS 3 AND 4 AND ADJOINING STREETS OF MAC BOWYER REPLAT OF BLOCKS 3, 4, 5, 8, 9, 10, 11 AND 12 OF BOWYER ADDITION TO THE CITY OF ABILENE.

WHEREAS, a petition has been presented by the owners of Mac Bowyer Replat of Blocks 3, 4, 5, 8, 9, 10, 11 and 12 of Bowyer Addition, therefore;

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF ABILENE:

That Blocks 3, 4, 5, 8, 9, 10, 11 and 12 and adjacent streets be and the same are hereby annexed to and included within the territory of the City of Abilene, said territory annexed being described by metes and bounds, as follows:

BEGINNING at the Northeast Corner of Lot 1, Block 3, of said Mac Bowyer Replat and in the present City Limits Line.

Thence South along the East boundary line of Block 3 of said Mac Bowyer Replat to the Southeast corner of Lot 5, Block 3 of said Mac Bowyer Replat, to a point for corner;

Thence East 60 feet across Palm Street continuing along the South Boundary line of Block 2 of Bowyer Addition, continuing East across Poplar Street to the Southwest Corner of Lot 7, Block 1, Bowyer Addition.

Thence South across South 22nd Street to the Northwest corner of Lot 12, Block 6, Bowyer Addition.

Thence West across Poplar Street and along the North Boundary Line of Block 5 of said Bowyer Replat to the Northwest Corner of said Lot 10, Block 5, of Bowyer Replat to point for corner.

Thence South along the West line of Block 5 of said Mac Bowyer Replat and across South 23rd Street to the Northwest corner of Lot 10, Block 8, of said Mac Bowyer Replat to point for corner;

Thence West across Palm Street and along the North Boundary line of Block No. 9 of said Mac Bowyer Replat, continuing West across Jeanette Street to a point 5 feet East of the West line of Jeanette Street to a point in the present City Limits line.

Thence North parallel with and 5 feet East of the West line of Jeanette Street and along the present City Limits line, to a point which is 5 feet East of the intersection of the West Boundary line of Jeanette Street and the South line of South 21st Street, which said point is in the present City Limits line.

Thence East across <sup>Jeanette</sup> ~~Block~~ Street and along the North line of Block 3 of the said Mac Bowyer Replat to the place of beginning.

Said territory is zoned in accordance with the Zoning Ordinance of the City of Abilene of 1946, and said territory is placed in Zone "B".

Passed on its first reading the 21st day of May, 1948.

After said passage, a notice of the time and place when and where said ordinance would be given a public hearing and considered for final passage, was published in the Abilene Reporter-News, a daily newspaper of general circulation in the City of Abilene, the first publication being at least one week prior to the time advertised.
