

ORDINANCE NO. 295

AN ORDINANCE ANNEXING LOTS 6 TO 10, INCLUSIVE IN BLOCK 5; LOTS 6 TO 10 INCLUSIVE IN BLOCK 8; AND ALL OF BLOCK 9 AND ADJOINING STREETS OF MAC BOWYER REPLAT OF BLOCKS 3, 4, 5, 8, 9, 10, 11 and 12, OF BOWYER ADDITION TO THE CITY OF ABILENE, TAYLOR COUNTY TEXAS.

WHEREAS, a petition has been presented by the owner of Lots 6 to 10 inclusive in Block 5; Lots 6 to 10 inclusive in Block 8; and all of Block 9 and adjoining streets of Mac Bowyer Replat of Blocks 3, 4, 5, 8, 9, 10, 11 and 12, of Bowyer Addition to the City of Abilene, Taylor County, Texas.

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF ABILENE: That Lots 6 to 10 inclusive in Block 5; Lots 6 to 10 inclusive in Block 8; and all of Block 9 and adjoining streets of Mac Bowyer Replat of Blocks 3, 4, 5, 8, 9, 10, 11 and 12, of Bowyer Addition to the City of Abilene, Taylor County, Texas, are hereby annexed to and included within the territory of the City of Abilene, said territory annexed being described by metes and bounds, as follows:

BEGINNING at the Northwest corner of Lot 1, Block 5 of said Mac Bowyer Replat and in the present City Limits Line.

THENCE South along the East boundary line of the 20 foot alley running through said Block 5, continuing South across South 24th street to the Northwest corner of Lot 1, Block 8 of said Mac Bowyer Replat, continuing South along the East boundary line of the 20 foot alley through said Block 8 to the Southwest corner of lot 5 in said Block 8, continuing South across South 25th Street to the Northwest corner of Lot 1, Block 11 of said Mac Bowyer Replat to a point for corner;

THENCE West along the North line of Block 11, continuing West across Palm Street and along the North line of Block 10, of said Mac Bowyer Replat, continuing West across Peach Street to a point 5 feet East of the West line of Peach Street to a point in the present City Limits Line.

THENCE North, parallel with and 5 feet East of the West line of Peach Street and along the present City Limits Line, to a point which is 5 feet East of the intersection of the West boundary line of Peach Street and the South line of South 24th Street which point is in the Present City Limits Line.

Said territory is zoned in accordance with the Zoning Ordinance of the City of Abilene of 1946, and said territory is placed in Zone "B".

Passed on its first reading the ²⁶16th day of November, 1948.


After said passage, a notice of the time and place when and where said ordinance would be given a public hearing and considered for final passage, was published in the Abilene Reporter-News, a daily newspaper

of general circulation in the City of Abilene, the first publication being at least one week prior to the time advertised. After such opportunity for the public to be heard said ordinance was passed on its second and final reading on the 10th day of December, A. D. 1948. ~~Said ordinance is filed in B-Zone.~~
