ORDINANCE NO. 340

AN ORDINANCE ANNEXING SECTION 4, ELMWOOD WEST ADDITION AND ADJOIN-ING STREETS, AND ESTABLISHING A ZONING DISTRICT.

WHEREAS, a petition has been presented by the owner of all of Section 4, Elmwood West Addition to the City of Abilene, Taylor County, Texas, requesting that said territory be annexed to the City of Abilene, and

WHEREAS, it appears that said territory adjoins and is contiguous to the corporate limits of said city, and

WHEREAS, the map or plat of said territory hereby annexed has been approved by the Planning Commission of the City of Abilene and the Board of Commissioners of said city in accordance with the provisions of Article 974a, Revised Civil Statutues of Texas, 1925, as amended.

NOW THEREFORE BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF ABILENE:

THAT Section 4 of Elmwood West Addition to the City of Abilene, Taylor County, Texas, together with all streets and alleys shown on the official map or plat of said Section 4, be and is hereby annexed to and included within the territory of the City of Abilene, said territory hereby annexed being described by metes and bounds as follows:

BEGINNING at a point in the N.B.L. of the Alexander Thompson Survey No. 37, 1425 feet West of its Northeast corner for the Northeast and beginning corner of this tract, Section 4;

THENCE South 235 feet to a point for a corner of this tract;

THENCE West 7.5 feet to a corner;

THENCE South 95 feet to a corner;

THENCE South 42 deg. and 15 min. West 60 feet to a corner;

THENCE South 73 deg. West 55 feet to a corner;

THENCE South 15 feet to a corner;

THENCE South 48 deg. East 68 feet to a corner;

THENCE South 35 deg. West 390 feet to a corner, said point being the Southeast corner of Section 4 and Southwest corner of Section 1;

THENCE North 59 deg. West 45 feet to a corner;

THENCE West 379 feet to a corner;

THENCE North 7.5 feet to a corner;

THENCE West 366.8 feet to a point for the Southwest corner of Section 4;

THENCE North 765 feet to the Northwest corner of Section 4;

THENCE East 998.1 fact to the place of harianing

Said territory is zamed in accordance with the Zoning Ordinance of the City of Abilene of 1946, and said territory is hereby placed in Zone "A" as the same is defined in said ordinance.

PASSED ON ITS FIRST READING THIS 6th day of January, A.D. 1950/

After said passage, a notice of the time and place when and where said ordinance would be given a public hearing and considered for final passage was published in the Abilene Reporter-News, a daily newspaper of general circulation in the City of Abilene, the first publication being at least one week prior to the time advertised.

After such opportunity for the public to be heard, said ordinance was PASSED ON ITS SECOND AND FINAL READING ON THE 20th day of January, A.D. 1950.
