

ORDINANCE NO. 353

AN ORDINANCE ANNEXING A PART  
OF HALE ADDITION AND ADJOINING  
STREETS TO THE CITY OF ABILENE,  
TEXAS, AND ESTABLISHING A ZON-  
ING DISTRICT.

WHEREAS the City of Abilene is the owner of all of the hereinafter  
described property, and

WHEREAS it appears that said territory adjoins and is contiguous to  
the corporate limits of the City of Abilene, and

WHEREAS it appears advantageous and proper to include said property  
within the corporate limits of said city,

NOW THEREFORE BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY  
OF ABILENE:

THAT a portion of Hale Addition to the City of Abilene, and adjoining  
streets be and the same is hereby annexed to and included within the territory  
of the City of Abilene, said territory hereby annexed being described by metes  
and bounds as follows; to-wit:

BEGINNING at the Southwest corner of Memorial Park Addition  
to the City of Abilene, which said point is in the East  
boundary line of Vine Street and the North line of South  
20th Street and in the present City Limit Line;

THENCE West across Vine Street 60 feet to the Southeast  
corner of Lot 8, Block 11, George Steakley's Subdivision of  
a part of the McMurry Park Addition;

THENCE South across South 20th Street a distance of 70  
feet to the Northeast corner of Lot 1, Block A, Hale  
Addition to the City of Abilene;

THENCE South with the West line of Vine Street a distance  
of 670 feet;

THENCE East across Vine Street a distance of 60 feet  
to the Northwest corner of Lot 1, Block F, of said Hale  
Addition, and continuing East to the Northeast corner of  
Lot 2, Block F, of said addition;

THENCE North across South 22nd Street a distance of 60  
feet to the Southwest corner of Lot 53, Block C, of said  
Addition;

THENCE North with the West line of said Block 53; 130 feet  
to the Northeast corner of said Lot 53;

THENCE East 50 feet to the Northeast corner of Lot 52,  
Block C of said Addition;

THENCE South with the East line of said Lot 52, 130 feet  
to the Southeast corner of said Lot 52;

THENCE West 50 feet to the Southwest corner of said  
Lot 53;

THENCE South across 22nd Street to the Northwest corner of Lot 3, of said Block F;

THENCE East 100 feet to the Northeast corner of Lot 6, of said Block F;

THENCE North across South 22nd Street 60 feet to the Southwest corner of Lot 49, of said Block C;

THENCE North 130 feet to the Northwest corner of said Lot 49;

THENCE East 50 feet to the Northeast corner of Lot 48 of said Block F;

THENCE South 130 feet to the Southeast corner of said Lot 48;

THENCE West 50 feet to the Southwest corner of said Lot 49;

THENCE South across South 22nd Street 60 feet to the Northwest corner of Lot 7 of said Block E;

THENCE East with the North boundary line of said block F and the South boundary line of South 22nd Street to the Northeast corner of Lot 23 of said Block F, and continuing in a straight line across Peach Street to a point where said line intersects the East line of Peach Street;

THENCE North with the East line of Peach Street to a point where said line intersects the North line of South 22nd Street;

THENCE West across Peach Street 60 feet to the Southeast corner of Lot 31, of said Block F; C

THENCE West 130 feet to the Southwest corner of said Lot 31;

THENCE North 150 feet to the Northwest corner of Lot 26; of said Block C;

THENCE East 130 feet to the Northeast corner of said Lot 26;

THENCE South 150 feet to the Southeast corner of said Lot 31;

THENCE East across Peach Street 60 feet to the East line of said Peach Street;

THENCE North with the East line of Peach Street a distance of 560 feet to a point where said line intersects the South boundary line of South 20th Street;

THENCE continuing in a straight line North to a point where said line intersects the North boundary line of South 20th Street;

THENCE West with the North boundary line of South 20th Street and the present City limit line to the place of beginning.




Said territory is zoned in accordance with the Zoning Ordinance of the City of Abilene of 1946, and said territory is hereby placed in Zone "B" as the same is defined in said ordinance.


PASSED ON ITS FIRST READING THIS <sup>24</sup> day of February, A.D. 1950

AFTER SAID PASSAGE, a notice of the time and place when and where said ordinance would be given a public hearing and considered for final passage was published in the Abilene Reporter-News, a daily newspaper of general circulation in the City of Abilene, the first publication being at least one week prior to the time advertised.

After such opportunity for the public to beheard, said ordinance was passed on its second and final reading on the <sup>10</sup>th day of March A.D. 1950.
