

ORDINANCE NO. 383

AN ORDINANCE ANNEXING SECTION
D, ELMWOOD WEST ADDITION TO
THE CITY OF ABILENE, TAYLOR
COUNTY, TEXAS TO THE CITY OF
ABILENE, TAYLOR COUNTY, TEXAS,
AND DECLARING AN EMERGENCY.

WHEREAS, A petition has been presented by the owner of Section
D, Elmwood West Addition to the City of Abilene, Taylor County,
Texas, to annex said property to the City of Abilene, Taylor
County, Texas.

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF ABILENE:

THAT Section D, Elmwood West Addition to the City of
Abilene, Taylor County, Texas, is hereby annexed to and included
within the territory of the City of Abilene, said territory
annexed being described by metes and bounds as follows, to-wit:

BEGINNING AT: The North East corner of Section # 1,
Elmwood West Addition to the City of Abilene, Taylor
County Texas, for the S.E. and beginning corner of this
Section "D" of Elmwood West Addition, Said point being
in the center of Big Elm Creek, and being the N.E. corner
of Alexander Thompson Survey # 37.

THENCE: West with the N.B.L. of said Section # 1,
Elmwood West, to its intersection with the E.B.L. of
Legett Drive, for the S.W. corner of this Section "D".

THENCE: North with the E.B.L. of Legett Drive 1457.5 feet
to a stake set for the N.W. corner of this Section "D".
THENCE: East 710.7 feet with the N.B. of Blocks 7 & 8,
of this Section "D", to a stake set for the N.E. corner
of said Section "D", said point being 15 feet East of
the center line of the ASTT pole line.

THENCE: South 24 deg. 10 min. West 898.64 feet to a stake
set in the N.B.L. of Blk # 2, of this Section "D" for
a corner of this tract.

THENCE: East to the Center of Big Elm Creek, for a corner
of this tract.

THENCE: Up Elm Creek with its meanders to the place of
beginning.

Said territory is zoned in accordance with the Zoning Ordinance of the City of Abilene of 1946, and Block 1 and 2 of said Section D are placed in "F" Zone and the remainder of said Section D is placed in "C" zone.

PASSED on its first reading the 30th day of June, A.D. 1950.


The Board of Commissioners hereby finds that an emergency exists requiring suspension of the rule provided in Section 32 of the City Charter requiring ordinance to be read and passed at two separate meeting of the Board of Commissioners and said rule is hereby suspended and said ordinance is hereby read and passed twice at one and the same meeting of said Board.

A PETITION TO ANNEX SECTION D
ELMWOOD WEST ADDITION OF 13.8 plus
ACRES OF LAND BEING PART OF THE
JOHN TUMLINSON SURVEY # 36
TAYLOR COUNTY, TEXAS, TO THE
CITY OF ABILENE.

TO THE HONORABLE BOARD OF COMMISSIONERS OF THE CITY OF ABILENE:

I, W. S. Wagley, Trustee, being the sole owner of the following described property, do hereby petition your honorable body to annex Section D, Elmwood West Addition of 13.8 plus acres of land being part of John Tumlinson Survey # 36 Taylor County, Texas, together with immediately adjacent streets, constituting a solid body of land and contiguous to and adjacent to the present boundaries of said city and being uninhabited territory to be included in the boundaries of said city, said property together with immediately adjacent streets being described as follows:

BEGINNING AT: The North East corner of Section # 1, Elmwood West Addition to the city of Abilene, Taylor County Texas, for the S. E. and beginning corner of this Section "D" of Elmwood West Addition. Said point being in the center of Big Elm Creek:

THENCE: West with the N. B. L. of said Section # 1, Elmwood West, to it's intersection with the E. B. L. of Legett Street, for the S.W. corner of this Section "D".

THENCE: North with the East Boundary Line of Legett Street 1457.5 feet to a stake set for the N. W. corner of this Section # "D".

THENCE: East 710.7 feet with the N. B. of Blocks 7 & 8, of this Section "D", to a stake set for the N.E. corner of said Section "D", said point being 15 feet East of the center line of the ASTT pole line.

THENCE: South 24 deg 10 min West 898.64' to a stake set in the N.B.L. of Blk # 2, of this Section "D" for a corner of this tract.

THENCE: East to the center of Big Elm Creek, for a corner of this tract.

THENCE: up Elm Creek with it's meanders to the place of beginning.


