AN ORDINANCE ANNEXING SECTION
E. ELMWOOD WEST ADDITION TO
THE CITY OF ABILENE, TAYLOR
COUNTY, TEXAS TO THE CITY OF
ABILENE, TAYLOR COUNTY, TEXAS.
AND DECLARING AN EMERGENCY

WHEREAS, A petition has been presented by the owner of Section E, Elmwood West Addition to the City of Abilene, Taylor County, Texas, to annex said property to the City of Abilene, Taylor County, Texas.

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF ABILENE:

THAT Section E, Elmwood West Addition to the City of Abilene, Taylor County, Texas, is hereby annexed to and included within the territory of the City of Abilene, said territory annexed being described by metes and bounds as follows, to-wit:

THENCE: West with the N.B.L. of Section D, Blk # 2 to the E.B.L. of alley which forms the E.B.L. of Section D.

THENCE: North 24 deg. 10 min. East at 898.64 feet pass the N.E. corner of Section D, of Elmwood West, and continuing a total distance of 947.64 feet to the N.W. corner of this Section E.

THENCE: East 316 feet to the center of Big Elm Creek for the N.E. corner of this Section E. And being the N.E. corner of Sub. # 1 of John Tumlinson Survey # 36.

THENCE: Up Elm Creek with its meanders to the place of beginning.

Said territory is zoned in accordance with the Zoning Ordinance of the City of Abilene, of 1946, and said addition is placed in "A" Zone.
