

ORDINANCE NO. 385

AN ORDINANCE ANNEXING SECTION
5, ELMWOOD WEST ADDITION TO
THE CITY OF ABILENE, TAYLOR
COUNTY, TEXAS TO THE CITY OF
ABILENE, TAYLOR COUNTY, TEXAS
AND DECLARING AN EMERGENCY

WHEREAS, a petition has been presented by the owner of Section
5, Elmwood West Addition to the City of Abilene, Taylor County,
Texas, to annex said property to the City of Abilene, Taylor
County, Texas.

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF ABILENE:

THAT Section # 5, Elmwood West Addition to the City of
Abilene, Taylor County, Texas, is hereby annexed to and included
within the territory of the City of Abilene, Said territory
annexed being described by metes and bounds as follows, to-wit:

BEGINNING AT: a point 2423.1 feet West and 765 feet
South of the NE corner of the Alexander Thompson
Survey # 37 for the NW and beginning corner of this
survey, Section # 5, said point also being the SW
corner of Section # 4.

THENCE: South 2739.4 feet to a stake set in the S.B.L.
of Hartford St. for a corner of this survey.

THENCE: Southeasterly with the S.B.L. of Hartford
St. to a stake set in the N.B.L. of Highway # 158,
for a corner of this survey.

THENCE: East with the NBL of said Highway # 158,
415.15 feet to the SW corner of Section # 2 for the
SE corner of this tract.

THENCE: N. 7 deg E 150 feet to a point for a corner
of this tract.

THENCE: N. 27 deg. 30 min. E. 166 feet to a point for
a corner of this tract, said point being in the S.B.L.
of Sub. # 1, and the NBL of Sub. # 9, 330 feet West
of their common East corner.

THENCE: N. 40 deg. E 652 feet to a point for a corner
of this tract.

THENCE: N. 69 deg. 30 min W. 156 feet to a point for
a corner of this tract.

THENCE: N. 7 deg. E. 342 feet to a point for a corner
of this tract.

THENCE: N. 12 deg. E. 241 feet to a point for a corner
of this tract.

THENCE: N. 22 deg. E. 293 feet to a stake set for a
corner of this Survey and the SE corner of Section # 3.

THENCE: N. 68 deg. 30 min. W. 424 feet to a stake set
for a corner of this survey.

THENCE: N. 62 deg. 30 min. W 426 feet to a stake set
for a corner of this survey and the SW corner of
Section # 3.

THENCE: N. 9 deg. E. 211.5 feet to a stake set for a
corner of this survey.

THENCE: N. 19 deg. 45 min. East 358 feet to a stake
set for a corner of this survey.

THENCE: N. 28 deg. 15 min. E. 216 feet to a stake set
for the NE corner of this survey, Section # 5, and the
SE corner of Section # 4, and the NW corner of Section
3, and the SW corner of Section # 1.

THENCE: N. 59 deg. W. 45 feet to a stake set for a
corner of this survey.

THENCE: W. 379 feet to a stake set for a corner of this survey.

THENCE: N 71⁵ feet to a stake set for a corner of this survey.


THENCE: W. 366.8 feet to the place of beginning.

Said territory is zoned in accordance with the Zoning Ordinance of the City of Abilene of 1946, and said addition is placed in "A" Zone.

Passed on first reading the 30th day of June, A.D. 1950.

The Board of Commissioners hereby finds that an emergency exists requiring suspension of the rule provided in Section 32 of the City Charter requiring ordinance to be read and passed at two separate meetings of the Board of Commissioners and said rule is hereby suspended and said ordinance is hereby read and passed twice at one and the same meeting of said Board.
