ORDINANCE NO. 388

AN ORDINANCE ANNEXING TO THE CITY OF ABILENE A TRACT OF LAND OUT OF THE NORTH HALF OF SECTION 34, BLIND ASYLUM LANDS, TAYLOR COUNTY, TEXAS, TO THE CITY OF ABILENE;: SAID ORDINANCE ESTABLISHING ZONING DISTRICT IN SAID TERRITORY IN ACCORDANCE WITH THE ZONING ORDINANCE OF THE CITY OF ABILENE OF 1946.

WHEREAS, application has been made in writing to the Board of Commissioners of the City of Abilene for the annexation to said City of the hereinafter described property, and

whereas, it appears that said application has been signed by a majority of those residing in said territory who are qualified to vote for members of the Legislature of the State of Texas, and said application is proved by the affidavit of James E. Freeman that the signatures thereto are genuine, and

WHEREAS, it appears that said property is contiguous and adjacent to said City;

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF ABILENE:

That the following described property be and the same is hereby annexed and included within the corporate limits of the City of Abilene, said property being more fully described as follows:

A tract of land out of the North half of Section 34, Blind Asylum Lands, Taylor County, Texas, described by metes and bounds as follows: BEGINNING AT AN iron pipe set for the N.W. corner of the East 40 acres of the N.W. quarter of Section No. 34, Blind Asylum Lands, for the Northwest and beginning corner of this tract; said point being in the South boundary line of Ambler Avenue extended; THENCE East 1350 feet with the South Boundary Line of Ambler Avenue to a stake set at the intersection of the East boundary line of Avenue D with the South boundary line of Ambler Avenue, for the Northeast corner of this tract; THENCE South 1/4 degree East 1735 feet with the East boundary line of Avenue D, to its intersection with the North boundary line of North 19th Street for the Southeast corner of this tract; THENCE West 1157 feet with the North boundary line of North 19th Street crossing Cedar Crest Drive to a stake set for the Southwest corner of this tract; THENCE North 35 feet to a stake set for the Southeast corner of Lot No. 1, Block No. 34, of this subdivision for a corner of this tract; THENCE West 200 feet with the South boundary line of Lot No. 1, Block No. 34, to a stake set for the Southwest corner of this THENCE North 1700 feet to the place of beginning.

PASSED ON FIRST READING this the 7th day of July, A.D. 1950.

After said passage a notice of the time and place when and where said ordinance would be given a final hearing and considered for final passage was published in the Abilene Reporter-News, a daily newspaper of general circulation in said City, the first publication being at least one week prior to the time advertised. After such opportunity for the public to be heard, said ordinance was PASSED ON ITS SECOND AND FINAL READING ON THE 21st day of July, A.D. 1950. All of the above described property is hereby placed in "B" Zone in accordance with the provisions of the Zoning Ordinance of the City of Abilene of 1946.
