WHEREAS, it appears that said property is contiguous and adjacent to said City:

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF ABILENE:

That the following described property be and it is hereby annexed and included within the corporate limits of the City of Abilene, said property being more fully described as follows:

The West 1/2 of Block 18, Abilene Heights Addition to the City of Abilene, Taylor County, Texas, and abutting streets, the same being described by metes and bounds as follows:

BEGINNING at the Northeast corner of Lot 1, Block 19 of said Addition, which said point is in the present city limit line;

THENCE North with the West boundary line of Cedar Crest Drive to the Southeast corner of Lot 1, replat of Block 34, of said Addition;

THENCE in an Easternly direction across Cedar Crest Drive to the Southwest corner of Lot 1, replat of Block 59 of said Addition;

THENCE East with the South boundary line of said Lot 1, to the Southwest corner of Lot 9, replat of said block 59;

THENCE in a Southeasternly direction to the Northwest corner of Lot 31, Block 18, of said addition;

THENCE South with the East line of an alley running North and South through said Block 18 to the Southwest corner of Lot 14 of said Block 18;

THENCE West with the South boundary line of said 121 Ar Lot 14 and with the present city limit line to the place of beginning.

After said passage a notice of the time and place when and where said ordinance would be given a final hearing and considered for final passage was published in the Abilene Reporter-News, a daily newspaper of general circulation in said City, the first publication being at least one week prior to the time advertised. After such opportunity for the public to be heard, said Ordinance was passed on its second and final reading on the 28th day of July, A.D. 1950. All of the above described property hereby annexed is placed in Zone "B", in accordance with the provisions of the Zoning Ordinance of the City of Abilene of 1946.
