ORDINANCE NO. 716

ORDINANCE OF THE CITY OF ABILENE ANNEXING TO THE CITY OF ABILENE BLOCKS 20 THROUGH 31 INCLUSIVE, SECTION 2 OF GREEN ACRES ADDITION TO THE CITY OF ABILENE, TAYLOR COUNTY, TEXAS, AND THE WEST HALF OF BLOCKS 16, 17, AND 18, OF SECTION 3 OF GREEN ACRES ADDITION TO THE CITY OF ABILENE, TAYLOR COUNTY, TEXAS; PROVIDING FOR THE ZONING OF THE SAME AND GRANTING THE RIGHTS AND PRIVILEGES OF THE CITIZENS OF THE CITY TO THOSE RESIDING IN SAID TERRITORY; DECLARING AN EMERGENCY AND PASSING ON SECOND AND FINAL READING.

WHEREAS, the following described property is land or territory lying adjacent to the present city limits of the City of Abilene; and,

WHEREAS, it appears expedient and necessary to the Board of Commissioners of the City of Abilene, that said property be annexed for all purposes in accordance with the City Charter, and request has been made therefor:

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF ABILENE:

SECTION I: That in accordance with Section 4 of the Charter of the City of Abilene, Texas, as amended, the following described property is hereby annexed to and included in the corporate limits of the City of Abilene, said territory being adjacent to the present city limit lines and being described as follows:

BEING ALL OF Blocks 20 through 31, inclusive, of Section 2 of Green Acres Addition to the City of Abilene, Taylor County, Texas; and the West Half of Blocks 16, 17, and 18, of Section 3 of Green Acres Addition to the City of Abilene, Taylor County, Texas.

SECTION 2:Being that property from North 18th Street on the South to Voge Street on the North, from the Alley East of Bridge Street to Minter Lane on the West. SECTION 3:Being that property composing one tier of lots facing west on Minter Lane between North 12th Street and North 13th Street, being adjacent to the City Limits Line of Green Acres Addition to the City of Abilene,

SECTION II: That upon final passage hereof, the said property as annexed shall be part of the City of Abilene, Taylor County, Texas, and of Abilene Independent School District, and the property situated herein shall bear its pro-rata portion of the taxes levied by the City and the School District, and the inhabitants thereof shall be entitled to all the rights, and privileges of all the citizens and shall be bound by the Acts, Ordinances, Rules and Regulations of the City.

SECTION III: Said property shall be zoned as follows:
All of Section 2 of Green Acres Addition shall be in Zone B,
except Block 29 and a part of Block 28, which shall be in
Zone F, and Blocks 30 and 31, which shall be in Zone C; all
of Section 3 of Green Acres Addition shall be in Zone B,
all as shown by plat of record and previously approved
all in accordance with the provisions of the Zoning Ordinance
of theCity of Abilene, as amended.

PASSED ON FIRST READING This the 20th day of April, 1956.

AFTER the passage of said ordinance on first reading, it being deemed necessary and it having been proven to the Commission that it was necessary to pass this ordinance to meet an emergency in accordance with Section 32 of the Charter of the City of Abilene, the rule requiring publication at least thirty (30) days prior to a public hearing and requiring such hearing, was suspended by a vote of four members of the Board of Commissioners and said ordinance was read and passed on second and final reading on the 20th day of April, 1956.
