

MINANCE OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, TO  
CHANGE THE NAMES OF CERTAIN STREETS.

WHEREAS, the Street named Stadium Way by Ordinance dated September 1,

1960, has not become a continuous "Loop" street as was planned, and;

WHEREAS, the streets within the alignment of said Stadium Way have been called by both the old name and Stadium Way since said date;

WHEREAS, it is the opinion of the City of Abilene that parts of Stadium Way should be renamed to eliminate confusion;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE  
CITY OF ABILENE, TEXAS:

SECTION 1: That the name of Stadium Way from Brookhollow Drive to Winters Freeway is hereby changed to Southwest Drive; That the names of South 27th Street, Stadium Way, South 28th Street and South 29th Street all within the alignment of Stadium Way from Brookhollow Drive to Maple Street shall be South 27th Street; That Stadium Way and Lytle Trail within the alignment of Stadium Way from Maple Street to State Highway Loop 322 shall be East South 27th Street; That East Horizon Road, Lytle Way and Port Road shall be South Stadium Way.

SECTION 2: That the City Engineer be, and he is hereby, authorized and directed to change his maps, plats and records to indicate such name.

SECTION 3: That the City Planning Department be, and is hereby, authorized and directed to change its maps, plats and records to reflect such name, and further that the City Planning Department shall provide notice of the naming of such street to any other City department, including the Fire and Police Departments, affected by such change.

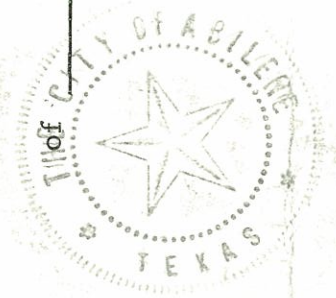
