AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS
RENAMING FORESTER STREET AS FOSTER LANE.

WHEREAS, Forester Street runs from Pine Street to Cedar Street and is located two to three hundred feet north of Lowden Street ; and,

WHEREAS, various residents who live on Forester Street have experienced difficulty with postal service due to the name of such street and have requested that such street name be changed to Foster Lane; and,

WHEREAS, it is the opinion of the City Council that Forester Street should be named Foster Lane; now therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

PART 1: That Forester Street which extends from Pine Street to Cedar Street and is approximately two to three hundred feet north of Lowden Street be named and will hereafter be known as Foster Lane.

PART 2: That the City Engineer be and is hereby authorized and directed to change his maps, plats and records to include such name to be the proper name of the street above described.

PART 3: That the City Planning and Zoning Department be and is hereby authorized and directed to change its maps, plats and records to reflect such name change and further that the City Planning and Zoning Department shall provide notice of the renaming of such street to all other city departments including Fire and Police Departments.
