

ORDINANCE NO. 118-1980

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, CHANGING THE NAME OF SYCAMORE STREET TO SPINDLETOP DRIVE.

WHEREAS, it is the recommendation of the Planning and Zoning Commission of the City of Abilene that Sycamore Street, in the City of Abilene, which is south of Industrial Boulevard for a distance of 1,418 feet, should be renamed Spindletop Drive; and,

WHEREAS, it is the opinion of the City Council that Sycamore Street should be renamed Spindletop Drive; now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

PART 1: That Sycamore Street, which is south of Industrial Boulevard for a distance of 1,418 feet, be renamed and will hereafter be known as Spindletop Drive.

PART 2: That the City Engineer be and is hereby authorized and directed to change his maps, plats and records to include such name to be the proper name of the street described above.

PART 3: That the Planning and Community Development Department be, and is hereby authorized and directed to change its maps, plats and records to reflect such name change, and further that the Planning and Community Development Department shall provide notice of the renaming of such street to all other City departments including the Fire and Police Departments.
