AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, CHANGING THE NAME OF COREY DRIVE TO CROSSROADS DRIVE.

WHEREAS, it is the recommendation of the Planning and Zoning Commission of the City of Abilene that Corey Drive, in the City of Abilene, which is west of Buffalo Gap Road for a distance of approximately 475 feet, should be renamed Crossroads Drive; and,

WHEREAS, it is the opinion of the City Council that Corey Drive should be renamed Crossroads Drive; now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

PART 1: That Corey Drive, which is west of Buffalo Gap Road for a distance of approximately 475 feet, to be renamed and will hereafter be known as Crossroads Drive.

PART 2: That the City Engineer be and is hereby authorized and directed to change his maps, plats and records to include such name to be the proper name of the street described above.

PART 3: That the Planning and Community Development Department be, and is hereby authorized and directed to change its maps, plats and records to reflect such name change, and further that the Planning and Community Development Department shall provide notice of the renaming of such street to all other City departments including the Fire and Police Departments.

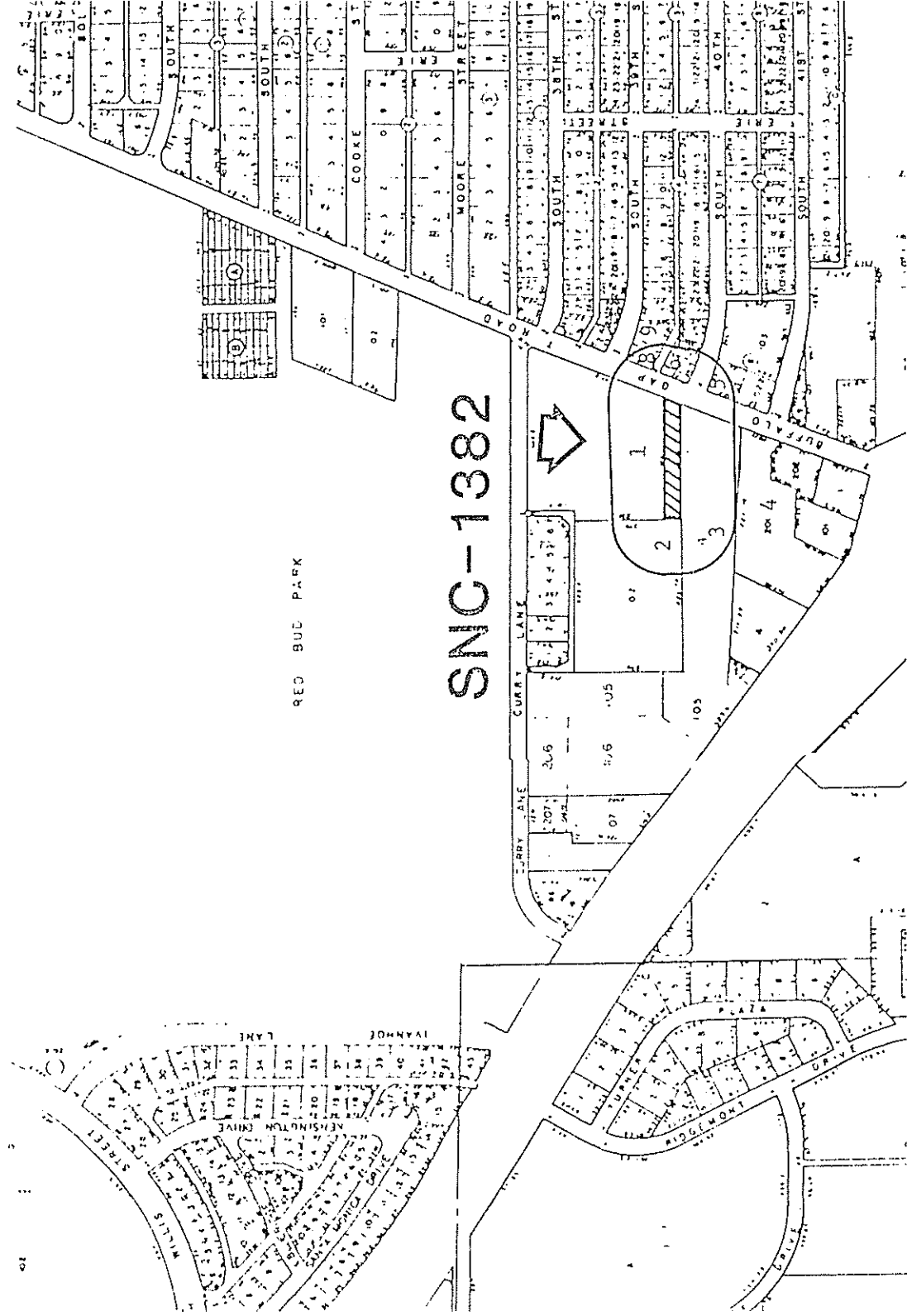

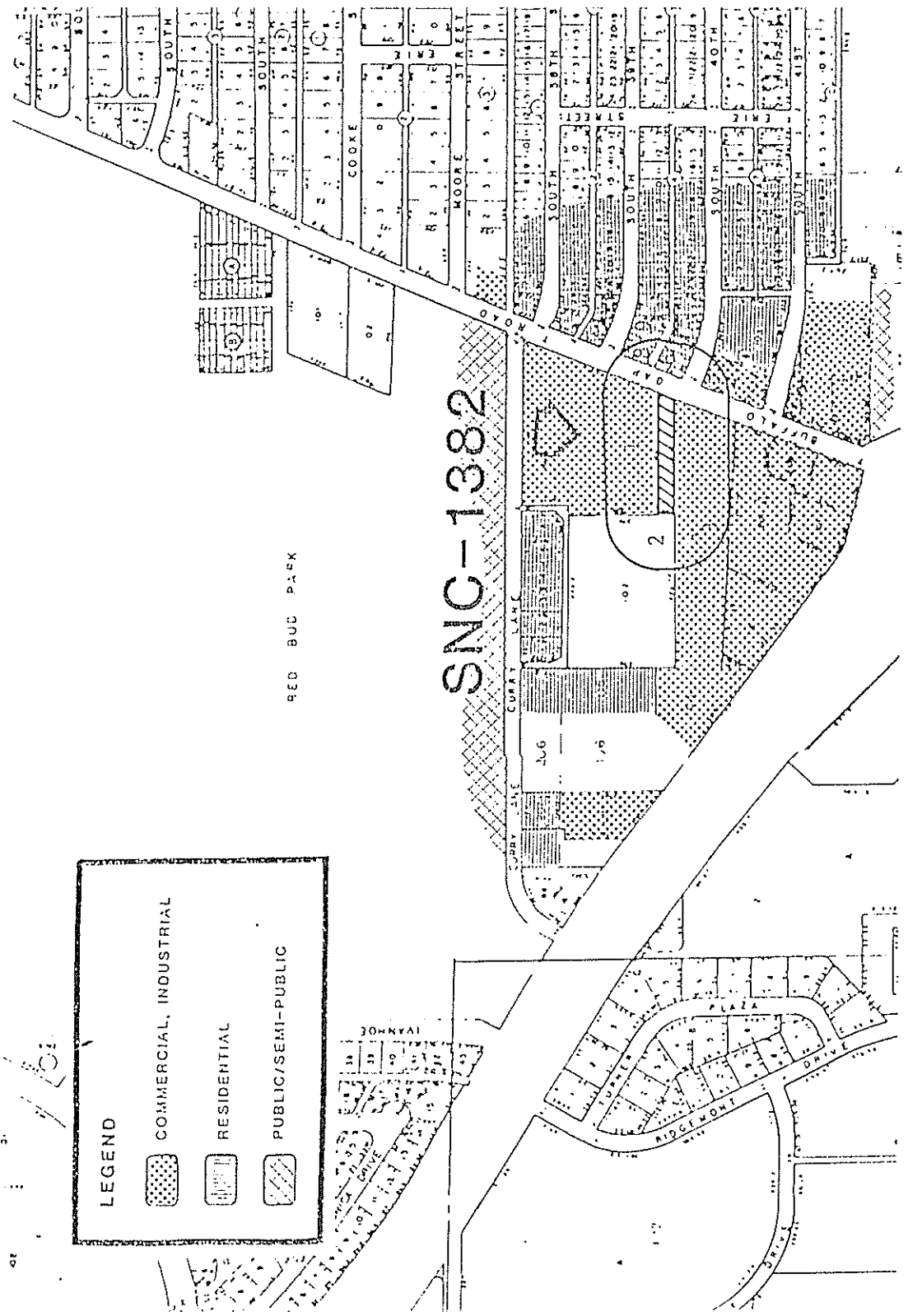

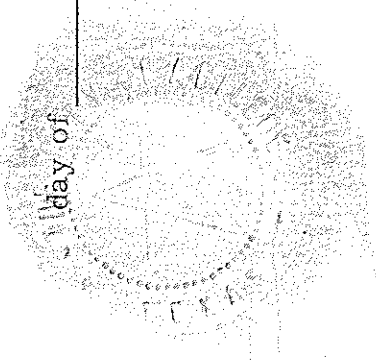
