

ORDINANCE NO. 46-1982

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, CHANGING THE NAME OF MCGEE DRIVE TO EXECUTIVE DRIVE.

WHEREAS, it is the recommendation of the Planning and Zoning Commission of the City of Abilene that McGee Drive, in the City of Abilene, which is an east-west segment and west of Maple Street for a distance of approximately 2,600 feet, should be renamed Executive Drive; now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

PART 1: That McGee Drive, which is an east-west segment and west of Maple Street for a distance of approximately, 2,600 feet, be renamed and will hereafter be known as Executive Drive.

PART 2: That the City Engineer be and is hereby authorized and directed to change his maps, plats and records to include such name to be the proper name of the street described above.

PART 3: That the Planning and Community Development Department be, and is hereby authorized and directed to change its maps, plats and records to reflect such name change, and further that the Planning and Community Development Department shall provide notice of the renaming of such street to all other City departments including the Fire and Police Departments.

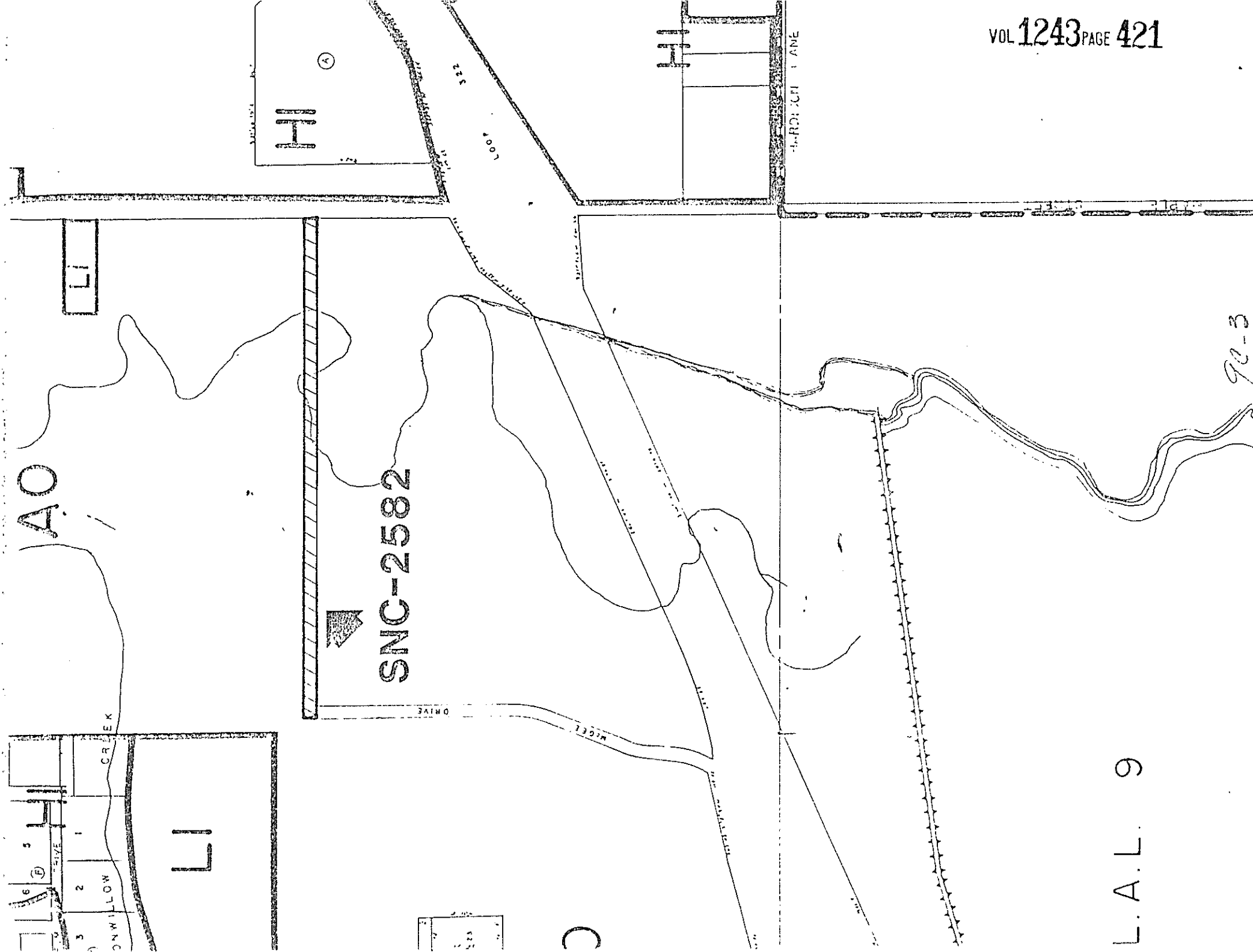

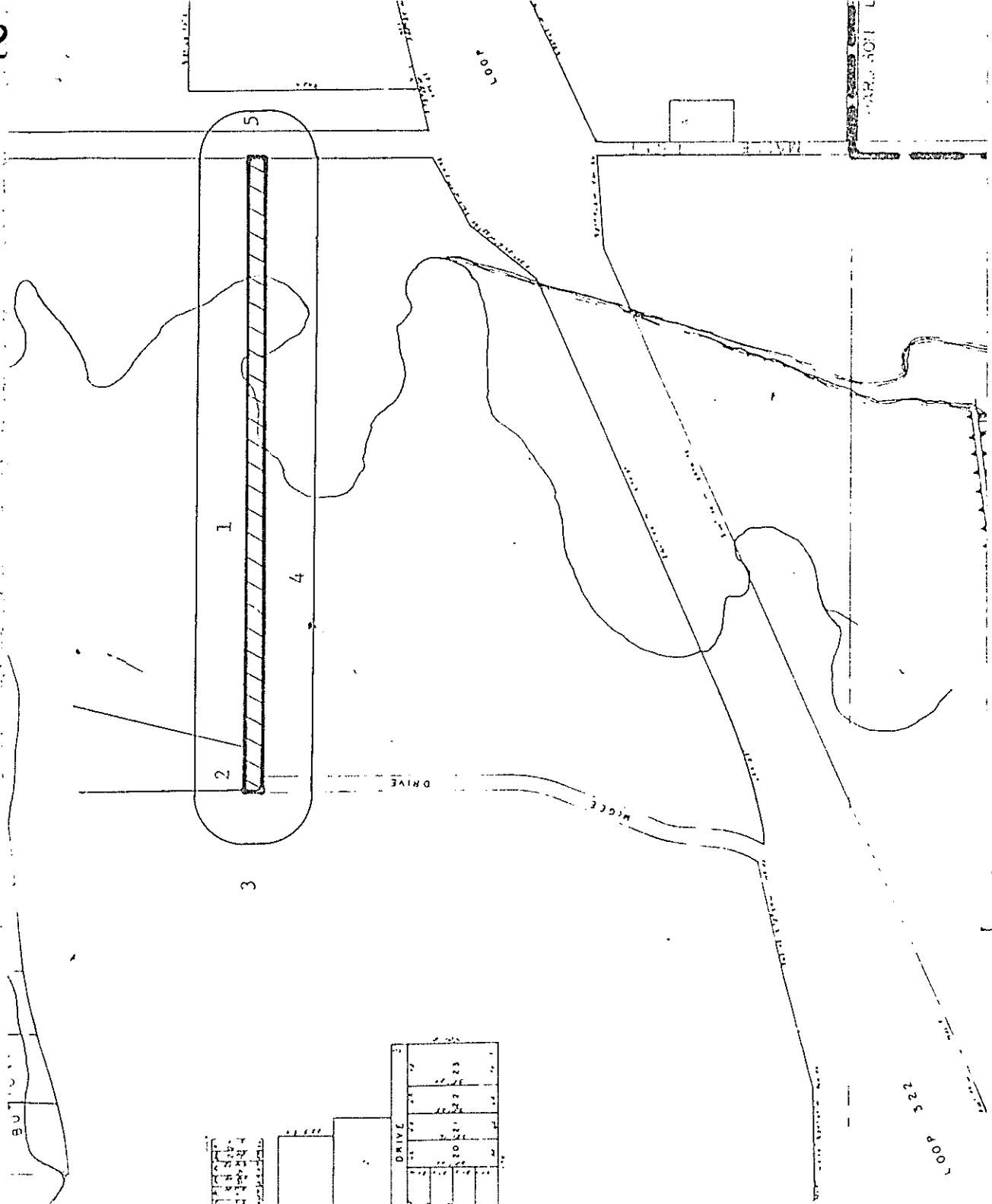

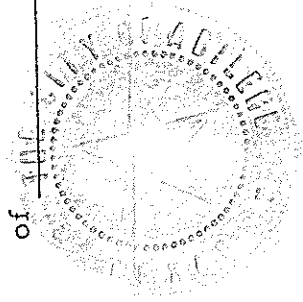
