

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, CHANGING THE NAME OF POVERTY POINT CIRCLE TO POVERTY POINT CIRCLE, DIXON ROAD, ARROW POINT, KIOWA COURT, WICHITA CAMP, COVE ROAD, YAW ROAD, CHEROKEE CIRCLE AND RAMP ROAD: AND COMMANCHE TRAIL TO COMANCHE TRAIL, CHOCTAW POINT, APACHE LANE, AND CHEYENNE CIRCLE

WHEREAS, it is the recommendation of the Planning and Zoning Commission of the City of Abilene that Poverty Point Circle and Commanche Trail, in the City of Abilene, which are located around Fort Phantom Lake, should be renamed Poverty Point Circle, Dixon Road, Arrow Point, Kiowa Court, Wichita Camp, Cove Road, Yaw Road, Cherokee Circle and Ramp Road; and Comanche Trail, Choctaw Point, Apache Lane, and Cheyenne Circle; and,

WHEREAS, it is the opinion of the City Council that Poverty Point Circle and Commanche Trail, which are located around Fort Phantom Lake, should be renamed Poverty Point Circle, Dixon Road, Arrow Point, Kiowa Court, Wichita Camp, Cove Road, Yaw Road, Cherokee Circle and Ramp Road; and Comanche Trail, Choctaw Point, Apache Lane, and Cheyenne Circle (see exhibit "A"); now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

PART 1: That Poverty Point Circle and Commanche Trail, which are located around Fort Phantom Lake, be renamed and will hereafter be known as Poverty Point Circle, Dixon Road, Arrow Point, Kiowa Court, Wichita Camp, Cove Road, Yaw Road, Cherokee Circle and Ramp Road; and Comanche Trail, Choctaw Point, Apache Lane, and Cheyenne Circle (see exhibit "A").

PART 2: That the City Engineer be and is hereby authorized and directed to change his maps, plats and records to include such name to be the proper name of the street described above.

PART 3: That the Planning and Development Department, be and is hereby authorized and directed to change its maps, plats and records to reflect such name changes, and further that the Planning and Development Department shall provide notice of the renaming of such streets to all other City departments including the Fire and Police Departments.

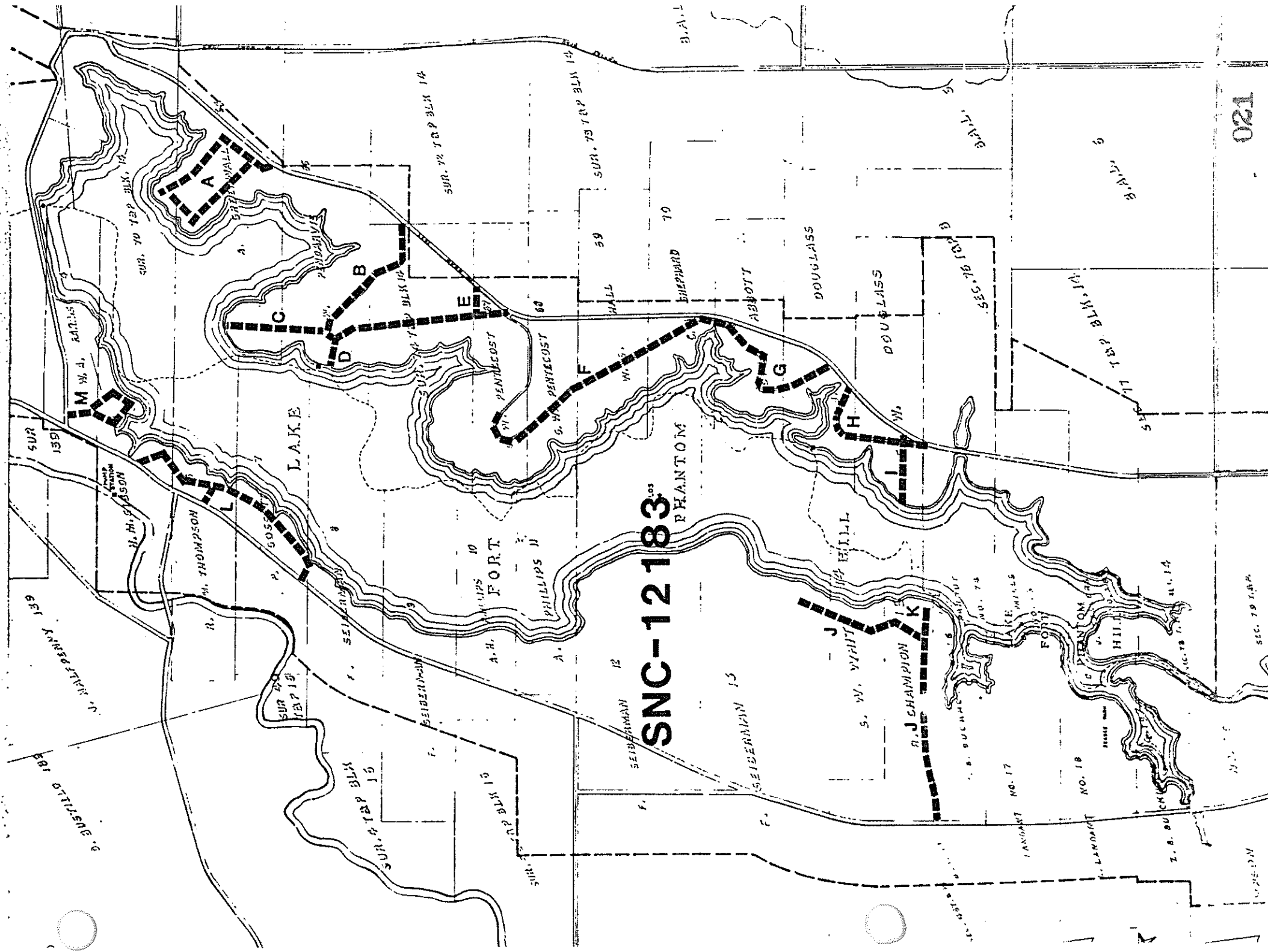
