

AN ORDINANCE AMENDING CHAPTER 6, "ANIMALS AND FOWL", CHAPTER 8 "CONSTRUCTION REGULATIONS", CHAPTER 11, "FOOD AND FOOD HANDLERS", CHAPTER 13, "HEALTH AND SANITATION", CHAPTER 16, "MASSAGE ESTABLISHMENTS", CHAPTER 20, "OFFENSES", CHAPTER 21, "OIL AND GAS", CHAPTER 22, "PARKS AND RECREATION", CHAPTER 23, "PLANNING AND COMMUNITY DEVELOPMENT", AND CHAPTER 29, "STREETS AND SIDEWALKS", OF THE ABILENE MUNICIPAL CODE, BY AMENDING CERTAIN SECTIONS AS SET OUT BELOW.

WHEREAS, a user fee study was a goal of the City Council in May, 1985, and

WHEREAS, a user fee study was completed in July, 1986, and

WHEREAS, the purpose of a user fee study was to cover the cost for providing services, and

WHEREAS, it is appropriate that fees be set by the City Council, and

WHEREAS, the staff is authorized to establish certain fees, and

WHEREAS, said fees are now being moved from certain sections from previous Ordinances, now, therefore:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

Part 1: That the above chapters of the Abilene Municipal Code be amended as set out in Exhibit "A", attached hereto and made a part of this ordinance for all purposes.


Part 2: That if any provision or any section of this ordinance shall be held to be void or unconstitutional such holding shall in no way affect the validity of the remaining provisions or sections of this ordinance, which shall remain in full force and effect.

Part 3: Said ordinance shall become effective October 1, 1986.
