

AN ORDINANCE OF THE CITY OF ABILENE, TEXAS, APPROVING THE ASSESSMENT ROLL FOR 1987, LEVYING AN AD VALOREM TAX FOR THE CITY OF ABILENE, TEXAS, FOR THE YEAR 1987; PROVIDING FOR THE ASSESSMENT AND COLLECTION THEREOF; REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

PART 1: That the assessment roll for the year 1987, as compiled by the Assessor-Collector of Taxes for the City of Abilene, and amended and approved by the Appraisal Review Board of the City of Abilene, on the 24th day of July, 1987, be, and the same is hereby, in all things, approved and adopted.

PART 2: That there be, and is hereby levied, on all of the property located in the City of Abilene, Texas, on the 1st day of January, 1987, and not exempt from taxation by the Constitution and Laws of the State of Texas and the City of Abilene, an ad valorem tax in the aggregate total of ~~--- forty-eight and sixty-six hundredths cents (48.66¢) ---~~ on each One Hundred Dollars' (\$100.00) valuation of said property, apportioned as follows:

<u>General Fund:</u>	
(a) Current	\$.4066
<u>Debt Service Funds:</u>	
(a) All Series Prior to 1979	\$.0068
(b) 1986 Series Advance Refunding	\$.0587
(c) 1987 Series	<u>\$.0145</u>
TOTAL TAX FOR THE YEAR 1987	<u>\$.4866</u>

PART 3: That there be, and are hereby authorized exemptions as follows:

- 1) Homestead exemption; fifteen percent (15%)
- 2) Age 65 and over exemption; \$15,000

PART 4: That notice for the public hearing on the 27th day of August, 1987, was given by publication in the Abilene Reporter-News on the 16th of August, 1987.



PART 6: That this ordinance shall take effect immediately from and after its date of final passage.


