

ORDINANCE NO. 70-1987

AN ORDINANCE AMENDING CHAPTER 18, "MOTOR VEHICLES AND TRAFFIC", OF THE ABILENE MUNICIPAL CODE, BY AMENDING CERTAIN SECTIONS AS SET OUT BELOW; PROVIDING A SEVERABILITY CLAUSE; AND DECLARING A PENALTY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

PART 1: That Chapter 18, "Motor Vehicles and Traffic", of the Abilene Municipal Code be amended as set out in Exhibit "A", attached hereto and made a part of this ordinance for all purposes.


PART 2: That if any provisions or any section of this ordinance shall be held to be void or unconstitutional, such holding shall in no way effect the validity of the remaining provisions or sections of this ordinance, which shall remain in full force and effect.


PART 3: That any person, firm or corporation violating any of the provisions of this chapter shall be deemed guilty of a misdemeanor, and upon conviction thereof shall be punished by a fine of not more than Two Hundred Dollars (\$200.00). Each day such violation shall continue or be permitted to continue, shall be deemed a separate offense. Said Ordinance, being a penal ordinance, becomes effective ten (10) days after its publication in the newspaper, as provided by Section 19 of the Charter of the City of Abilene.



Section 18-293, Parking Prohibited - At All Times.

DELETE:

<u>Street</u>	<u>Side</u>	<u>Extent</u>
Alameda Rd	Both	From South 7th St south a distance of 150 feet.
Bruce Way	West	From Amanda Lane to Shanna Lane

ADD:

<u>Street</u>	<u>Side</u>	<u>Extent</u>
Alameda Rd	East	From South 7th St to Pueblo Dr.
Alameda Rd	West	From South 7th St south a distance of 150 feet.
Arrow Point	West	A 60 foot section adjacent to the Lake Patrol boat storage building located 0.4 mile north of Dixon Rd.
Bruce Way	West	From Amanda Lane to Bruce Way
Bruce Way	East	From Ruswood Dr north a distance of 50 feet.
Ruswood Dr	North	From 50 feet west of Bruce Way to 50 feet east of Bruce Way.

Section 18-299, Parking Time Limited

DELETE:

<u>Street</u>	<u>Side</u>	<u>Extent</u>
Walnut St	East	From North 2nd St to North 3rd St.
North 2nd St	South	From Walnut St west to the alley.

ADD:

<u>Street</u>	<u>Side</u>	<u>Extent</u>
Walnut St	East	From alley south of North 2nd St to North 3rd St.
North 2nd St	South	From alley east of Walnut St to alley west of Walnut St.
