

AN ORDINANCE AMENDING CHAPTER 18, "MOTOR VEHICLES AND TRAFFIC", OF THE ABILENE MUNICIPAL CODE, BY AMENDING CERTAIN SECTIONS AS SET OUT BELOW; PROVIDING A SEVERABILITY CLAUSE; AND DECLARING A PENALTY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

PART 1: That Chapter 18, "Motor Vehicles and Traffic", of the Abilene Municipal Code be amended as set out in Exhibit "A", attached hereto and made a part of this ordinance for all purposes.

PART 2: That if any provisions or any section of this ordinance shall be held to be void or unconstitutional, such holding shall in no way effect the validity of the remaining provisions or sections of this ordinance, which shall remain in full force and effect.

PART 3: That any person, firm, or corporation violating any of the provisions of this chapter shall be deemed guilty of a misdemeanor, and upon conviction thereof shall be punished by a fine of not more than Two Hundred Dollars (\$200.00). Each day such violation shall continue or be permitted to continue, shall be deemed a separate offense. Said Ordinance, being a penal ordinance, becomes effective ten (10) days after its publication in the newspaper, as provided by Section 19 of the Charter of the City of Abilene.

Section 18-291. Through Streets; Stop, Yield Intersections.

ADD:

<u>Street</u>	<u>Intersection or Extent</u>
South 15th St	Barrow St to Ross Ave
South 16th St	Barrow St to Ross Ave
South 19th St	Barrow St to Ross Ave
Hunt St	Barrow St to Ross Ave

Section 180293. Parking Prohibited - At all times.

DELETE:

<u>Street</u>	<u>Side</u>	<u>Extent</u>
Texas Ave	Both	From entrance gate to Dyess Housing Area to a point 250 feet east of such gate
Willis St	West	From S. 14th St to a point 125 feet south of S. 15th St

ADD:

<u>Street</u>	<u>Side</u>	<u>Extent</u>
S. 32nd St	North	From 150 feet east to 100 feet west of Barrow St
S. 32nd St	South	From 150 west to 100 feet east of the Redbud Park entrance road
S. 7th St	North	From a point 400 feet west of Leggett Drive west a distance of 120 feet
EN 10th St	Both	From 300 feet west of Judge Ely Blvd to 300 feet east of Bruce Way
Pioneer Dr, South	Both	From S. 1st St to Don Juan St
Willis St	Both	From S. 14th St to a point 125 feet south of S. 15th St
