

ORDINANCE NO. 41-1988

AN ORDINANCE APPROVING REVISED BUDGET FIGURES FOR FISCAL YEAR 1987-1988; APPROVING AND ADOPTING BUDGET FOR THE FISCAL YEAR OCTOBER 1, 1988, THROUGH SEPTEMBER 30, 1989, FOR THE CITY OF ABILENE; APPROPRIATING FUNDS; REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH; CALLING A PUBLIC HEARING.

WHEREAS, the City Manager has prepared a revision of certain figures in the 1987-1988 budget and submitted same to the City Council; and,

WHEREAS, the City Manager on July 5, 1988, filed a proposed budget with the City Secretary for the fiscal year commencing October 1, 1988; and,

WHEREAS, the City Council has reviewed and considered said proposed budget and made revisions of same; and,

WHEREAS, said proposed budget, as revised by the City Council, was duly set for a public hearing ordered to be called by the City Council and held on 8/25/88, after due notice, as required by the Charter of the City of Abilene and laws of the State of Texas; now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

PART 1: That the revised figures, prepared and submitted by the City Manager for the 1987-1988 budget, be, and the same are hereby, in all things, approved and appropriated, and any necessary transfers between accounts and departments are hereby authorized, approved and appropriated.

PART 2: That the budget proposed by the City Manager for the fiscal year commencing October 1, 1988, as revised by the City Council, be, and the same is hereby approved, adopted and appropriated including transfers of General Fund equity to various Funds.

PART 3: That upon passage of this ordinance on first reading, the City Secretary be, and is hereby authorized and directed to have published in the Abilene Reporter-News, a daily newspaper of general circulation in the City of Abilene, a notice that a public hearing will be held in the Council Chambers of the City Hall in Abilene, Texas, at 9:00 A.M., on the 25 day of August, 1988, to permit the public to be heard prior to consideration of this ordinance for second and final reading, said publication to be made more than ten (10) days prior to the time designated for such public hearing.

PART 4: That any ordinance, resolution, policy or any provision or section of the code of the City of Abilene, Texas, as amended, in conflict herewith, be, and the same is hereby repealed to the extent of any conflict.

PART 5: That the number, classification and designation of each position, as provided in Article 1269m, Vernon's Texas Civil Statutes, for the Police and Fire Departments, as set out below, are hereby created, established and adopted as the official plan for the classified service of the Police and Fire Departments of the City of Abilene for the fiscal year October 1, 1988, through September 30, 1989. The Chief Inspector shall receive Assignment Pay in an amount necessary to make Chief Inspector base pay equivalent to District Chief base pay. Any position in the classified service of the Police and Fire Departments of the City of Abilene not below listed, is hereby abolished:

PASSED ON FIRST READING on the 19 day of July, A.D. 1988.
