

AN ORDINANCE AMENDING CHAPTER 18, "MOTOR VEHICLES AND TRAFFIC", OF THE ABILENE MUNICIPAL CODE, BY AMENDING CERTAIN SECTIONS AS SET OUT BELOW; PROVIDING A SEVERABILITY CLAUSE; AND DECLARING A PENALTY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

PART 1: That Chapter 18, "Motor Vehicles and Traffic", of the Abilene Municipal Code be amended as set out in Exhibit "A", attached hereto and made a part of this ordinance for all purposes.

PART 2: That if any provisions of any section of this ordinance shall be held to be void or unconstitutional, such holding shall in no way effect the validity of the remaining provisions or sections of this ordinance, which shall remain in full force and effect.

PART 3: That any person, firm, or corporation violating any of the provisions of this chapter shall be deemed guilty of a misdemeanor, and upon conviction thereof shall be punishable by a fine of not more than Five Hundred Dollars (\$500.00). Each day such violation shall continue or be permitted to continue, shall be deemed a separate offense. Said Ordinance, being a penal ordinance, becomes effective ten (10) days after its publication in the newspaper, as provided by Section 19 of the Charter of the City of Abilene.



ADD:

N. 10th St	From Clack St to Wall St	40 mph

Section 18-293. Parking Prohibited--At All Times

ADD:

<u>Street</u>	<u>Side</u>	<u>Extent</u>
N. 10th St	Both	From Clack St to 200 feet west of Wall St
Lynwood Ln	North	From 380 feet west of Leggett Dr, west 50 feet
Redbud Cir	Both	From 80 feet west of Leggett Dr, west 40 feet
Redbud Cir	North	From 350 feet west of Leggett Dr, west 80 feet
Redbud Cir	South	From 350 feet west of Leggett Dr, west 100 feet
Redbud Cir	East	From Lynwood Ln south 80 feet
Redbud Cir	West	From 270 feet south of Don Juan St south 40 feet

Section 18-299. Parking Time Limit
