

ORDINANCE NO. 12-1991

AN ORDINANCE AMENDING CHAPTER 18, "MOTOR VEHICLES AND TRAFFIC", OF THE ABILENE MUNICIPAL CODE, BY AMENDING CERTAIN SECTIONS AS SET OUT BELOW; PROVIDING A SEVERABILITY CLAUSE; AND DECLARING A PENALTY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

PART 1: That Chapter 18, "Motor Vehicles and Traffic", of the Abilene Municipal Code be amended as set out in Exhibit "A"; attached hereto and made a part of this ordinance for all purposes.


PART 2: That if any provisions of any section of this ordinance shall be held to be void or unconstitutional, such holding shall in no way effect the validity of the remaining provisions or sections of this ordinance, which shall remain in full force and effect.


PART 3: That any person, firm, or corporation violating any of the provisions of this chapter shall be deemed guilty of a misdemeanor, and upon conviction thereof shall be punishable by a fine of not more than Five Hundred Dollars (\$500.00). Each day such violation shall continue or be permitted to continue, shall be deemed a separate offense. Said Ordinance, being a penal ordinance, becomes effective ten (10) days after its publication in the newspaper, as provided by Section 19 of the Charter of the City of Abilene.



Section 18-285. Increased Speed Limits.

DELETE:

Old Anson Rd	From Ambler Avenue to I-20	35
Old Anson Rd	From I-20 to Winters Freeway	40
Rebecca Ln	From Buffalo Gap Rd to west City limits	40

ADD:

<u>Street</u>	<u>Extent</u>	<u>Speed</u>
Old Anson Rd	From Ambler Ave to I-20	40
Old Anson Rd	From I-20 to Winters Freeway	45
Rebecca Ln	From Buffalo Gap Rd to Catclaw Dr	40
Rebecca Ln	From Catclaw Dr to 1,000 feet west of Catclaw Dr	45
Rebecca Ln	From 100 feet west of Catclaw Dr to US 277	55

Section 18-293. Parking Prohibited - At All Times.

DELETE:

Old Anson Rd	East	From Sandefer St to alley south of Sandefer St
Rebecca Ln	Both	From Buffalo Gap Rd to Catclaw Creek

ADD:

Old Anson Rd	Both	From Ambler Ave to 500 feet north of Impact Dr
Rebecca Ln	Both	From Buffalo Gap Rd to US 277
