AN ORDINANCE AMENDING CHAPTER 23, "PLANNING AND COMMUNITY DEVELOPMENT," SUBPART E, "ZONING," OF THE ABILENE MUNICIPAL CODE, BY CHANGING THE ZONING DISTRICT BOUNDARIES AFFECTING CERTAIN PROPERTIES, AS DESCRIBED BELOW, DECLARING A PENALTY, AND CALLING A PUBLIC HEARING.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

PART 1: That Chapter 23, Subpart E, known as the Zoning Ordinance of the City of Abilene, is hereby amended by changing the zoning district boundaries as set out in Exhibit "A," attached hereto and made a part of this ordinance for all purposes.

PART 2: That any person, firm or corporation violating any of the provisions of this chapter shall be deemed guilty of a misdemeanor, and upon conviction thereof, shall be punished by a fine of not more than Two Thousand Dollars (\$2,000.00). Each day such violation shall continue or be permitted to continue, shall be deemed a separate offense.

EXHIBIT "A"

Rezone property from AO (Agricultural Open Space) to LC (Limited Commercial) zoning district.

Legal Description:

BEING 4.82 acres out of a 7.17 acre tract out of Survey No. 22, Lunatic Asylum Lands, Taylor County, Texas, and being described by metes and bounds as follows:

BEGINNING at a point on the west boundary line of said 7.17 acre tract and the east boundary line of a certain 10 acre tract for the southwest corner of this tract, from which the northwest corner of Survey No. 22 bears S 89°55' W 812.3 feet and N 0°05' W 2661.25 feet;
