

AN ORDINANCE AMENDING CHAPTER 18, "MOTOR VEHICLES AND TRAFFIC", OF THE ABILENE MUNICIPAL CODE, BY AMENDING CERTAIN SECTIONS AS SET OUT BELOW; PROVIDING A SEVERABILITY CLAUSE; AND DECLARING A PENALTY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

PART 1: That Chapter 18, "Motor Vehicles and Traffic", of the Abilene Municipal Code be amended as set out in Exhibit "A", attached hereto and made a part of this ordinance for all purposes.


PART 2: That if any provisions of any section of this ordinance shall be held to be void or unconstitutional, such holding shall in no way effect the validity of the remaining provisions or sections of this ordinance, which shall remain in full force and effect.

PART 3: That any persons, firm, or corporation violating any of the provisions of this chapter shall be deemed guilty of a misdemeanor, and upon conviction thereof shall be punishable by a fine of not more than Five Hundred Dollars (\$500.00). Each day such violation shall continue or be permitted to continue, shall be deemed a separate offense. Said Ordinance, being a penal ordinance, becomes effective ten (10) days after its publication in the newspaper, as provided by Section 19 of the Charter of the City of Abilene.



Section 18-293, Parking Prohibited – At All Times.

ADD:

<u>Street</u>	<u>Side</u>	<u>Extent</u>
Clack St	West	From Fairmount St to S. 14 th St
Danville Dr	East	From S. 14 th St to 710 feet south of Hartford St

Section 18-299, Parking Time Limited.

(c) One hour limit: 8:00 a.m. to 4:00 p.m., school days only.

DELETE:

<u>Street</u>	<u>Side</u>	<u>Extent</u>
N. 5 th St	Both	From Shelton St to alley east of Shelton St

ADD:

<u>Street</u>	<u>Side</u>	<u>Extent</u>
N. 5 th St	South	From Shelton St to alley east of Shelton St

(e) Thirty-minute limit: At any time:

DELETE:

<u>Street</u>	<u>Side</u>	<u>Extent</u>
S. 14 th St	South	From east curb line of Jeanette St to a point 150 feet east

Section 18-304, Parking Designated for the Disabled.

ADD:

<u>Street</u>	<u>Side</u>	<u>Extent</u>
N. 3 rd St	North	From Cedar St east 50 feet
