

ORDINANCE NO. 47-2018

AN ORDINANCE AMENDING CHAPTER 18, "MOTOR VEHICLES AND TRAFFIC," ARTICLE XIII, "SCHEDULES," SECTION 18-293. "PARKING PROHIBITED AT ALL TIMES," AND SECTION 18-294. "SAME DURING CERTAIN HOURS" OF THE ABILENE MUNICIPAL CODE, BY AMENDING CERTAIN SECTIONS AS SET OUT BELOW; PROVIDING A SEVERABILITY CLAUSE; AND DECLARING A PENALTY

WHEREAS, The Carver Neighborhood has requested removal of No Parking zones that were established by Traffic Services working with the Abilene Police Department to curb drug activity in the area; and

WHEREAS, the Carver Neighborhood has changed throughout the years, there is no longer a need for these parking restrictions.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

PART 1: That Chapter 18, Article XIII, Section 18-293 of the Abilene Municipal Code be amended as set out in Exhibit "A" attached hereto and made a part of this ordinance for all purposes.

PART 2: That Chapter 18, Article XIII, Section 18-294 of the Abilene Municipal Code be amended as set out in Exhibit "A" attached hereto and made a part of this ordinance for all purposes.

PART 3: That if any provisions of any section of this ordinance shall be held to be void or unconstitutional, such holding shall in no way effect the validity of the remaining provisions or sections of this ordinance, which shall remain in full force or effect.

PART 4: That any persons, firm, or corporation violating any of the provisions of this Ordinance shall be deemed guilty of a misdemeanor and upon conviction thereof shall be punishable by a fine in accordance with Chapter 1 (Section 1-9) of this Code. Each day such violation shall continue or be permitted to continue, shall be deemed a separate offense. Said Ordinance, being a penal ordinance, becomes effective ten (10) days after its publication in the newspaper, as provided by Section 19 of the Charter of the City of Abilene.

PASSED ON FIRST READING this 9th day of August, A.D., 2018.

A notice of the time and place, where and when said ordinance would be given a public hearing and considered for final passage was published in the Abilene Reporter-News, a daily newspaper of general circulation in the City of Abilene, said publication being on 19th day of August, 2018, the same being more than 24 hours prior to a public hearing being held in the Council Chamber of City Hall in Abilene, Texas, at 4:30 p.m. on the 23th day of August, 2018 to permit the public to be heard.

Sec. 18-293. Parking prohibited—At all times.

In accordance with the provisions of this chapter, and when signs are erected giving notice thereof, no person shall at any time park a vehicle upon the indicated side of any of the following streets or portions of streets:

North 8th St.	South	From Ash St. to Plum St.
	South	From Plum St. to the alley to the west
North 9th St.	North	Plum St. to alley west of Plum St.
	South	Plum St. to 75 feet west of Plum St.
North 13th St.	Both	From Cottonwood to Ash Sts.
	South	From Plum to Ash Sts.
Ash St.	Both	From 150 feet north of North 11th St. to 150 feet south of North 14th St.
Plum St.	East	From North 2nd to North 3rd Sts.

Sec. 18-294. Same—During certain hours.

In accordance with the provisions of this chapter, and when signs are erected giving notice thereof, no person shall park a vehicle during the times specified in this schedule on the indicated sides of the following streets or portions of streets:
