## ORDINANCE NO. 56-2024

AN ORDINANCE AMENDING CHAPTER 18, "MOTOR VEHICLES AND TRAFFIC," ARTICLE XIII, "SCHEDULES," SECTION 18-289.1, "ONE WAY STREETS – DURING CERTAIN TIMES," OF THE ABILENE MUNICIPAL CODE, BY REMOVING A SECTION AS SET OUT BELOW; PROVIDING A SEVERABILITY CLAUSE;

WHEREAS, the current use of traffic design at Crockett Early Head Start facility utilizes one-way traffic restriction on South 13<sup>th</sup> Street between Willis Street and Sunset Drive during certain hours of the morning and afternoon on school days; and

WHEREAS, the City Code of Ordinance provides direction for one-way streets during certain hours; and

WHEREAS, there is a need to amend the City Code of Ordinances to add a section of one-way street on South 13<sup>th</sup> Street between Willis Street and Sunset Drive adjacent to Crockett Early Head Start Facility.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

PART 1: That Chapter 18, Article XIII, Section 18-289.1 of the Abilene Municipal Code be amended as set out in Exhibit "A", attached hereto and made a part of this ordinance for all purposes.

PART 2: That if any provisions of any section of this ordinance shall be held to be void or unconstitutional, such holding shall in no way effect the validity of the remaining provisions or sections of this ordinance, which shall remain in full force or effect.

PART 3: Said Ordinance, being a penal ordinance, becomes effective ten (10) days after its publication in the newspaper, as provided by Section 19 of the Charter of the City of Abilene.

PASSED ON FIRST READING this 7th day of November 2024.

A notice of the time and place, where and when said ordinance would be given a public hearing and considered for final passage was published in the Abilene Reporter-News, a daily newspaper of general circulation in the City of Abilene, said publication being on the 17th day of November, 2024, the same being more than 24 hours prior to a public hearing being held in the Council Chamber of City Hall in Abilene, Texas, at 8:30 a.m. on the 21th day of November, 2024, to permit the public to be heard.
