

A RESOLUTION ANNEXING BLOCKS 32 AND 33 OF  
THE CONTINUATION OF ABILENE HEIGHTS,  
ADDITION TO THE CITY OF ABILENE.

WHEREAS, the owners of Blocks 32 and 33 of the continuation of Abilene Heights Addition to the City of Abilene signed by all of said land which lands constitute a solid body of land contiguous and adjacent to the City of Abilene and being an uninhabited territory therefore;

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE CITY OF ABILENE: That said territory be and the same is hereby annexed to the present corporate limits of the said City of Abilene which corporate limits are changed as follows:

Beginning at the present SW corner of said city limits at the intersection of the West line of Avenue E with the north boundary line of North 10th Street and thence West along the South boundary line of said Block No. 33 of the continuation of Abilene Heights;

Thence turning in a curve and along the West boundary line of said blocks Nos. 32 and 33 to the NW corner of said Block No. 32;

Thence East along the North boundary line of said Block 32 to its intersection with the West line of said Avenue E;

Thence South with the West boundary line of said Avenue E to the North boundary line of North 10th Street, the place of beginning, and there connecting with the original city limits. *Said territory is placed in "B" Zone.*
