

A RESOLUTION AUTHORIZING THE MAYOR AND CITY
SECRETARY TO RELEASE PAVING AND MECHANIC'S
LIENS.

WHEREAS, the City of Abilene has purchased, financed and sponsored many and sundry paving and mechanic's liens on skip paving and other individual projects for paving and improvement of the city streets throughout the City of Abilene; and

WHEREAS, the City of Abilene will in the future, in all probability, purchase, finance, and sponsor many and sundry Paving and Mechanic's liens on skip paving and other projects for paving and improvements of the City streets throughout the City of Abilene; and

WHEREAS, from time to time upon the payment of these liens it becomes necessary that they be properly released by the Mayor and attested by the City Secretary as required by law;

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE CITY OF ABILENE, TEXAS:

Section 1: That the Mayor of the City of Abilene be authorized and is hereby directed to sign all releases of paving and/or mechanic's and materialman's lien contracts now owned, or which may be owned hereafter, by the City of Abilene and which encumbers, or may hereafter encumber, property when the said Mayor is fully satisfied that the liens has been fully and completely paid, according to its terms and reading.

Section 2: That the City Secretary be authorized and is hereby directed to attest all such instruments so signed by the Mayor and to deliver the same to the individuals entitled to said releases
