A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, AUTHORIZING THE PURCHASE OF A PRE-FABRICATED GREEN HOUSE FOR THE USE OF THE PARKS DEPARTMENT FOR A TOTAL BID PRICE OF \$5, 164. 00; REJECTING BIDS SUBMITTED FOR THE PURCHASE OF A PRE-FABRICATED STEEL BUILDING; AUTHORIZING CONSTRUCTION OF A CONCRETE BLOCK BUILDING BY THE PARKS DEPARTMENT; AND APPROPRIATING \$6, 500. 00 FOR ACQUISITION AND CONSTRUCTION OF BOTH STRUCTURES.

WHEREAS, the City of Abilene duly advertised and gave such notice as required by law for bids on the purchase of a pre-fabricated greenhouse and a pre-fabricated steel building for the use of the Parks Department; and,

WHEREAS, bids for the purchase of the greenhouse were received on November 16, 1965, as follows:

Rough Brothers	6, 375. 00; and,

WHEREAS, on recommendation of the Parks and Recreation Board, it is the opinion of the City Council that the bid of National Greenhouse Company, in the total amount of \$5, 164. 00 should be accepted; and,

WHEREAS, on recommendation of the Parks and Recreation Board, it is the opinion of the City Council that all bids on the pre-fabricated steel building should be rejected; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

Section 1: That the Purchasing Agent be and is hereby authorized to purchase one pre-fabricated greenhouse from National Greenhouse Company for a total bid price of Five Thousand One Hundred Sixty-four Dollars (\$5, 164. 00).

Section 2: That all bids received for the construction of a pre-fabricated steel building be and are hereby in all things rejected and the Parks Department is hereby authorized to begin construction of a concrete block building for its use.


Section 3: That funds in the total amount of Six Thousand Five Hundred Dollars (\$6, 500. 00) be and are hereby appropriated from the 1964 Parks Improvement Bond Funds for the acquisition and construction of the above described structures.

Section 4: That this resolution shall take effect immediately from and after its

passage.
