A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, AUTHORIZING THE PURCHASE OF THREE TRUCKS AND TWO COMPACT CARS FOR THE USE OF THE CITY OF ABILENE, TEXAS.

WHEREAS, the City of Abilene duly advertised and gave, such notice as required by law for bids for the purchase of Three Trucks and Two Compact Cars for the use of the City; and,

WHEREAS, bids were received and opened on May 6, 1966, said bids being as follows:

WHEREAS, it is the opinion of the City Council that the bid of Taylor Chevrolet Company in the total amount of Two Thousand Eighty Five and 25/100 Dollars (\$2,085.26) is the lowest responsible bid for One (1) truck and should be accepted; that the bid of Arrow Ford Company in the total amount of Four Thousand Six Hundred Twenty Five & 34/100 Dollars (\$4,625.34) is the lowest responsible bid for Two (2) trucks and should be accepted; and that bid of Taylor Chevrolet Company in the total amount of Three Thousand and Seventy Eight & 46/100 Dollars (\$3,078.46) is the lowest responsible bid for Two (2) Compact cars and should be accepted; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE,

TEXAS:

Section 1: That the bid of Taylor Chevrolet Company, for the purchase of One (1) truck, in the total amount of \$2,085.26, be, and the same is hereby in all things approved and accepted.

Section 2: That the bid of Arrow Ford Company, for the purchase of Two (2) Trucks in the amount of \$4, 625. 34, be, and the same is hereby in all things approved and accepted.


Section 3: That the bid of Taylor Chevrolet Company, for the purchase of Two (2) Compact Cars in the amount of \$3, 078. 46, be, and the same is hereby in all things approved and accepted.

Section 4: That the Purchasing Agent be, and he is hereby authorized to purchase Three (3) Trucks and Two (2) Compact Cars from said firms.

Section 5: That this resolution shall take effect immediately from and after its passage.
